Abstract

I am following a trail of blood that runs from Wilkes-Barre to Butler, and from Moscow, Pennsylvania, to Moscow, Idaho. At each stop, innocent lives were destroyed and families left broken, while those in power treated their deaths as pieces on a political chessboard. These murders were not random. They were ritual, deliberate, and orchestrated.

The metaphor is simple: the **AutoPen** versus the **AutoKnife**. Presidents sign with the AutoPen — clean, efficient, distant. These networks, however, sign in blood with the AutoKnife. The families bury their dead while the architects walk away untouched.

On June 8, 2022, Nicholas Roske set out to stab (or shoot) U.S. Supreme Court Justice Brett Kavanaugh (BK1) in his own home — to silence another conservative voice on the Court and to hand Joe Biden a second opening to fill. Exactly two months later — to the day — on **08/08/2022**, the Mar-a-Lago home invasion occurred.

About three months after that, Bryan Kohberger (BK2) crossed into Moscow, Idaho, where he butchered four students in their sleep. The names and numbers surrounding this attack were not accidental; they tie back to Pennsylvania — Wilkes-Barre, Butler, and Moscow, PA itself — revealing a script, not coincidence.

The blood spilled in their bedrooms was not only the end of four young lives — it carried the hidden Halloween narrative of the house number **1122**, timed and staged like a ritual sacrifice. It echoed the kind of anti-woman bloodshed Pennsylvania has gotten away with before — the double murder at the dawn of the Space Age, when **Joan Marie Dymond** and **Mary Jo Kopechne** were silenced in 1969.

Most recently, the same ritualistic script reached the national stage: the **proxy murder of Donald J. Trump** by a University of Pennsylvania graduate — not for personal grievance, but as a political message, a warning to all who would stand in the way.
