II. Parties

- Defendant: Bryan Christopher Kohberger ("Kohberger").
- Complainant/Affiant: Robert Joseph Antonellis.
- Potential co-conspirators and accessories: Names presently unknown; to be identified through investigative process.

III. Venue & Jurisdiction (Monroe County)

- A. Venue (overt acts in Monroe County). The conduct described below includes overt acts in Monroe County, PA, sufficient to lay venue here for Conspiracy and related offenses.
- B. **Territorial applicability.** Pennsylvania jurisdiction attaches where conduct outside the Commonwealth is part of a **conspiracy** with **overt acts** in Pennsylvania. See **18 Pa.C.S. § 102** (territorial applicability) and § **903** (conspiracy).
- C. Enterprise continuity (context). Planning and procurement activities originating in Pennsylvania formed material steps toward later homicides alleged to have occurred outside the Commonwealth.

IV. Factual Allegations (Summary of Overt Acts)

On or about March 20–30, 2022, within Monroe County, Pennsylvania, Kohberger undertook material overt acts in furtherance of a multi-state conspiracy to commit criminal homicide, including:

- 1. **Procurement of a large fixed-blade knife and sheath (KA-BAR style)** intended as an instrumentality of the planned offense.
- 2. **Planning and preparatory research/communications** originating from Kohberger's Monroe County domicile, including electronic communications and logistical planning consistent with targeted travel/surveillance outside Pennsylvania.
- 3. **Operational staging** activities reasonably associated with later travel, surveillance, and selection of intended targets, conducted while domiciled in Pennsylvania.

These **overt acts** are alleged to have been knowingly undertaken with the intent that homicides would be executed outside Pennsylvania at a later date. The alleged acts began in **Monroe County** and continued across state lines.

V. Charged Offenses (subject to amendment)

- 1. Criminal Conspiracy to commit Criminal Homicide 18 Pa.C.S. § 903, with object offense § 2502.
- 2. Criminal Solicitation (as appropriate to communications uncovered) 18 Pa.C.S. § 902.
- 3. Criminal Use of Communication Facility (planning/coordination via electronic means originating in PA) 18 Pa.C.S. § 7512.

Note: Additional charges (e.g., **Hindering Apprehension or Prosecution, § 5105**) may be supported as to third parties upon review of travel/transport, vehicle disposition, and post-offense communications. These are reserved pending discovery.
