2. The acts committed by the accused were:

On June 25, 1969, Wilkes-Barre native Joan Marie Dymond disappeared from her neighborhood in Wilkes-Barre, PA—just 23 days before fellow Wilkes-Barre native Mary Jo Kopechne was suffocated to death in Chappaquiddick, Martha's Vineyard. We allege these events were deliberately linked, orchestrated as symbolic murders to reset the identity of the Catholic Democratic Party of John F. Kennedy, through violence, hatred of women, and silence.

The pattern, hidden for decades, formally reemerged on June 25, 2009—exactly 40 years later—when Robert Hunter Biden, Christopher Heinz, Joseph Robinette Biden, and allies founded Rosemont Seneca Partners (RSP), ensuring Joe Biden's rise to power would be as feared as it would be unstoppable.

The name Rosemont Seneca associates the entity with ritual violence across state lines: in addition to the morbid choice of founding date, the name defined the Butler Bullseye—where Donald Trump was caught and shot on July 13, 2024. The Rosemont Seneca Corridor has Butler at dead center, where George Washington was nearly assassinated at age 21. Though Hunter was not yet born in 1969, senior actors, including Joe Biden and John Kerry, understood and honored the legacy this pattern represents.

This constitutes Criminal Conspiracy to Commit Murder under 18 Pa.C.S. § 903(c). Full evidentiary basis is provided in The Butler Brief (Core Complaint and Exhibits).
