**Re: Urgent Request for Jurisdictional Review & Referral of Relevant Case Materials**

**Dear District Attorney Goldinger and District Attorney Sanguedolce,**

In addition to the enclosed **BB0A\_Request\_for\_Jurisdictional\_Review\_and\_Case\_Delegation**, this letter formalizes the request for an independent investigation into the attempted assassination of former President Donald J. Trump, as well as associated criminal activities linked to the **Rosemont Network**. This network, tied directly to Joe Biden's political rise, is at the heart of this criminal operation.

This document serves as the **jurisdictional coordination roadmap** for **The Butler Brief** and the ongoing investigation into criminal activity that spans **multiple jurisdictions**, including **Butler County, Luzerne County**, and **several state and federal entities**. The crimes under investigation involve significant events, including:

1. **The East Palestine train derailment on 2/3/2023**, which has far-reaching **environmental** and **geopolitical consequences**, viewed as a likely **orchestrated disaster**.
2. **The \$6 billion release to Iran in September 2023**, which directly led to the **Hamas massacre on October 7, 2023**, signed on 9/11/23, the **centennial of Hitler's coup**.
3. **The attempted assassination of President Donald J. Trump in Butler, Pennsylvania, on July 13, 2024**.
4. **The suppression of evidence tied to Robert Hunter Biden's laptop**, with far-reaching **political** and **criminal implications**.
5. **The Manson Murders**, and their potential ties to the **Rosemont Network**, highlighting the intersection of **historical political violence** and ongoing corruption.
6. **The double murder investigation of Joan Marie Dymond and Mary Jo Kopechne**, which ties directly into **Chappaquiddick** and the **Rosemont Network's** history of **orchestrated political violence**.

This case involves **Joseph R. Biden** as the central defendant, along with **110 additional defendants** whose involvement spans a wide range of criminal activities. The investigation also includes **12 key witnesses** who can provide critical testimony and evidence to support the claims of conspiracy, financial fraud, and political violence. Additionally, **2 individuals are listed as Potential Co-Conspirators (PCCs)**, who are currently under investigation for their possible roles in the crimes. These individuals, together with Joseph R. Biden and the other defendants, form the core group under scrutiny for their involvement in orchestrating the series of criminal actions detailed in the Butler Brief.

Given the **multi-jurisdictional nature** of these crimes, we respectfully request that your offices coordinate their investigative efforts and take the necessary actions in their respective jurisdictions. The case has substantial implications at both the **state and federal levels**, and it is vital that all relevant authorities be involved.

In order to ensure a comprehensive review and handling of the case, I have provided additional detailed materials in **BB0B\_Request\_for\_Jurisdictional\_Review\_and\_Case\_Delegation**. This document further

outlines the case delegation process and the specifics of how materials should be handled, ensuring that the jurisdictional review is conducted thoroughly.

This letter, and the entire Butler Brief in digital format, is being **copied to the relevant Attorneys General**, who are being notified as part of this coordinated effort. Their involvement will be critical should the case require **statewide investigation** or if any **cross-jurisdictional issues** arise that require additional coordination.

I appreciate your **prompt attention** to this matter, and I am available to provide any further **documentation or clarification** necessary to move this investigation forward. Given the **high-profile nature** of these allegations and their far-reaching impact, we look forward to your **timely and coordinated response**.
