**Opening Statement:**

This **Prosecution Memorandum** is submitted to request the immediate and thorough investigation of crimes orchestrated by **Joseph R. Biden Jr.** and the **Rosemont Network**, a powerful group connected to high-profile political figures, financial entities, and international players. The actions detailed within this document have wide-ranging implications not only for the public safety and security of Butler County and Luzerne County but also for the integrity of the United States government and the rule of law.

At the heart of this investigation lies the Rosemont Network, which has used its influence and vast resources to manipulate and conceal illegal activities ranging from assassination attempts to staged environmental disasters, and from election racketeering to terrorist financing. These events are not isolated incidents; they are part of a broader conspiracy that threatens national security and undermines democratic integrity.

The network's reach extends far beyond Pennsylvania, with influence spanning both domestic and international policies. From Biden's early political career to the rise of **Dark Brandon**, his political ambition has been shaped by the secretive and corrupt dealings of the **Rosemont Network**, which has operated without regard for the law or the safety of the American people.

The evidence presented here shows the coordinated nature of these actions, all orchestrated to further the political and financial interests of a shadow network. The crimes outlined are of the highest urgency and demand immediate action from the Butler County District Attorney, the Luzerne County District Attorney, and the Pennsylvania Attorney General. We urge these authorities to pursue prosecution and take the necessary steps to uncover the truth, ensuring that justice is served.

**Key Events:**

This investigation centers around the following significant events, all deeply interconnected through the operations of the **Rosemont Network**:

- ☐ **The targeted assassination attempt on former President Donald J. Trump on July 13, 2024, in Butler, PA, linked to efforts to eliminate political opposition.**

- **The East Palestine train derailment on February 3, 2023**, orchestrated to further environmental and geopolitical manipulation with far-reaching consequences.
- **The \$6 billion release to Iran on September 11, 2023**, leading directly to the Hamas massacre on October 7, 2023, a global event manipulated by the network to advance its interests.
- **Maintaining the 9/11 Blood Chain**, with Biden's authorization of \$6 billion to Iran on 9/11/23, enabling the Hamas attack on Israel, 26-days later, and tying it to the legacy of 9/11 events.
- **The opening of the southern border under Joe Biden's administration**, aligned with the plans of the Open Society Foundations (OSF), funded by George and Alex Soros, inflicting irreparable damage on national sovereignty.
- **The suppression of evidence tied to Hunter Biden's laptop**, linked to Rosemont Seneca Partners LLC, exposing a web of corruption that extends well beyond Butler County.
- **The coordinated media narratives that manipulated public perception**, shielded those responsible for these actions, and discredited legitimate inquiries into their involvement.

## Legal Grounds and Statutory Violations:

The actions outlined in this memorandum are in violation of both **Pennsylvania State Law** and **federal law**, including but not limited to the following statutes:

- **Conspiracy (18 Pa.C.S. § 903)**  
The events described herein involve a coordinated effort by members of the Rosemont Network to manipulate, influence, and obstruct legal processes, including the attempted assassination of former President Donald J. Trump and the suppression of evidence tied to Hunter Biden's laptop.
- **Money Laundering (18 Pa.C.S. § 5111)**  
The Rosemont Network has used illicit financial operations to conceal and legitimize proceeds from criminal activities, including the coordinated manipulation of media narratives and the suppression of evidence.
- **Terrorism (18 Pa.C.S. § 2717)**  
The **East Palestine train derailment** on February 3, 2023, was orchestrated by the Rosemont Network to further political and geopolitical agendas, qualifying as an act of terrorism under **18 Pa.C.S. § 2717**, which prohibits acts intended to intimidate or coerce governments or civilians.
- **Corruption of Public Officials (18 Pa.C.S. § 4701)**  
Key figures within the Rosemont Network have used their political influence to corrupt public officials, undermining the integrity of state institutions, manipulating elections, political processes, and public safety.
- **Obstruction of Justice (18 U.S.C. § 1503)**  
The suppression and obstruction of evidence related to Hunter Biden's laptop and other criminal activities are clear violations of federal obstruction of justice statutes.
- **Foreign Corrupt Practices Act (15 U.S.C. § 78dd-1)**  
The Rosemont Network's connections to international financial corruption and foreign entities also constitute violations of the Foreign Corrupt Practices Act, further complicating the conspiracy and financial crimes tied to the group.
- **Financial Fraud and Terrorism (18 Pa.C.S. § 5111 & 18 Pa.C.S. § 2717)**  
The release of \$6 billion to Iran on September 11, 2023 (9/11/23) was not only a politically charged decision but also a clear act of financial fraud orchestrated by the Rosemont Network to further its geopolitical and financial agendas. This release directly funded Hamas, a recognized

terrorist organization, and served as a means of manipulating international financial systems to achieve political ends.

The timing of the release, coinciding with the 100th anniversary of Hitler's rise to power on 9/11/23 (German date format), was symbolic of the network's alignment with dark political forces, which sought to perpetuate chaos and influence global events through financial manipulation. The funding of Hamas via Iran not only constitutes a violation of financial regulations but also indirectly supported terrorism, making it a dual violation under both financial fraud and terrorism statutes.

## Requested Actions:

Based on the legal and factual findings outlined in this memorandum, we respectfully request the following actions from the Butler County District Attorney, Luzerne County District Attorney, Pennsylvania Attorney General, and relevant federal authorities:

1. **Butler County DA:** Prioritize the investigation into the July 13, 2024, assassination attempt on former President Donald J. Trump, ensuring the full scope of this event is connected to the Rosemont Network and its efforts to eliminate political opposition. This investigation should also interface with the U.S. Attorney General to ensure federal resources and support are brought to bear.
2. **Luzerne County DA:** Prioritize the investigation into the double murder of Mary Jo Kopechne and Joan Marie Dymond, ensuring that the PA State Police (Troop P) works alongside the Massachusetts State Police to share critical evidence and further investigate potential ties to the Rosemont Network and political corruption. This investigation should also interface with the U.S. Attorney General to connect federal jurisdiction as necessary.
3. **Pennsylvania Attorney General:** Examine the Rosemont Network, connecting the Trump assassination attempt and the double murder investigation, while coordinating with the Massachusetts Attorney General. Additionally, spearhead the initiation of a murder investigation into the curious death of Senator John Heinz III with the assistance of Federal law enforcement. This investigation should also interface with the U.S. Attorney General for coordination on national security and corruption matters.
4. **Department of Defense (DOD):** Investigate military infractions and potential illegal actions committed by Mark Milley, Lloyd Austin, and possibly other military figures involved in criminal activity related to national security, as outlined in this memorandum. This investigation should include oversight of military conduct related to the Rosemont Network and political violence.
5. **Grand Jury Investigation:** Convene a Grand Jury to investigate the broader conspiracy involving the Rosemont Network, including its connections to international financial fraud, terrorism, and political manipulation, as well as its influence over public officials.
6. **Subpoenas:** Issue subpoenas to compel the production of documents and testimony from key witnesses and potential co-conspirators to build the case further.

These actions are necessary to ensure accountability, uncover the full extent of the criminal activities orchestrated by the **Rosemont Network**, and restore public confidence in the legal and political systems.

## **Whistleblowers:**

Whistleblowers have long been the backbone of exposing systemic corruption and abuses of power. As a whistleblower, I am committed to revealing the hidden truths surrounding the Biden administration's criminal activities, particularly in connection with the Rosemont Network. The need to expose financial misconduct, murder, and political manipulation is central to this investigation. Whistleblowers have already proven instrumental in uncovering the truth, and it is imperative that their testimonies and contributions be recognized as a critical part of this criminal investigation.

By exposing these deep-rooted networks and bringing hidden facts to light, this investigation seeks to bring accountability and ensure that justice is served for the victims of these orchestrated acts of violence.

## **Tony Bobulinski's Testimony and the Need for Investigation:**

The testimony from Tony Bobulinski is critical in establishing the connection between Hunter Biden's criminal activities and Joe Biden's involvement in foreign financial dealings. Bobulinski's firsthand account, particularly regarding the "10% to the Big Guy" secret deal, demonstrates that Rosemont Seneca Partners LLC facilitated these illicit actions, effectively tying Hunter Biden's and the Biden family's financial misconduct to Joe Biden's two terms as Vice President and one term as President. Bobulinski's statements provide essential insight into Rosemont Network's operations and its influence on U.S. foreign policy. This substantiates the need for a grand jury or federal investigation into Rosemont Seneca's role in enabling these criminal activities.

## **Including Murder, Mass Murder, and Ritual Sacrifice:**

It is essential to address the murders committed as part of this investigation, particularly the Double Murder of Mary Jo Kopechne (MJK) and Joan Marie Dymond (JMD). These two tragic deaths, linked to political violence and ritual sacrifice, occurred 23 days apart—with JMD's abduction and murder on June 25, 1969, and MJK's death on July 18, 1969. This eerie timing raises significant questions about the involvement of political and occult networks in orchestrating these murders. Troop P of the Pennsylvania State Police is actively investigating this cold case for the murder of JMD, and it is critical that they connect with the Massachusetts State Police to share my evidence of a double murder, potentially uncovering deeper ties to the Rosemont Network.

This investigation is a call to recognize these deaths as deliberate, orchestrated events and demands that the legal authorities reclassify MJK's death as First-Degree Murder, aligning with the broader network of political violence and ritual sacrifice that extends through the operations of the Rosemont Network.

## **Conclusion and Next Steps:**

This investigation brings to light not only the political and financial crimes committed by powerful individuals but also the systemic abuses that have been allowed to flourish under the cover of secrecy and manipulation. The involvement of the Rosemont Network, the Biden family, and their connections to powerful financial backers like George Soros must be fully investigated, with a focus on their actions impacting U.S. sovereignty, national security, and public trust.

The critical next steps include:

- **Grand Jury Investigation:** An urgent call for a federal grand jury to investigate the financial ties between Rosemont Seneca and foreign powers, particularly through Hunter Biden.
- **Reclassification of MJK's Death:** Reopening the case of Mary Jo Kopechne and Joan Marie Dymond, with an official reclassification of MJK's death as murder.
- **Whistleblower Protection:** Ensuring that whistleblowers are properly supported and protected in order to bring all the hidden truths to light and allow justice to prevail.

**We urge the District Attorney's office to take immediate action on this request, ensuring justice for all victims and accountability for those behind this network of corruption.**
