# 1. Introduction: A Historic Complaint, Guided by Human Hands and AI **Precision**

This is not a typical criminal complaint. It is a historic one. It marks the first known case in American legal history where artificial intelligence—commissioned and directed by a private citizen—has been deployed to expose a long-running criminal conspiracy that has operated within the highest levels of U.S. government, spanning multiple presidential administrations, including the vice-presidential and presidential terms of Joe Biden.

It was the perfect melding of man and machine. I, Robert J. Antonellis, a Cum Laude graduate of UMass Amherst (1984) in Industrial Engineering and Operations Research, where I first studied the foundational principles of artificial intelligence, probability modeling, and pattern recognition, have applied these same tools, in their modern form, to uncover a massive criminal conspiracy. These are the same tools the U.S. government has used for decades in covert planning, war simulation, and geopolitical modeling.

Through meticulous research, I have mapped out the very tactics used by rogue elements within our government against the American people, spanning over 50 years. My work, validated by independent AI models like Grok-3 (xAI) and ChatGPT (OpenAI), presents a clear, data-driven path to dismantling what I have uncovered as the "Rosemont Network"—a web of political, financial, and criminal forces operating out of Pennsylvania, extending to other states, and reaching all the way to Washington, D.C., all under the shadow of Dark Brandon's influence.

This complaint presents an urgent plea for justice, revealing a hidden criminal conspiracy that stretches from Butler, Pennsylvania, to Washington, D.C., and key locations in Pennsylvania, such as Fox Chapel (home of Rosemont Farms, owned by Teresa Heinz Kerry), Lower Merion Township, and Scranton-Wilkes-Barre, where Joe Biden, Mary Jo Kopechne (MJK), and Joan Marie Dymond (JMD) were all natives. This network of power, influence, and deception, centered around Rosemont Seneca Partners (RSP), LLC, has its roots in Pennsylvania but extends to other U.S. states, involving political, financial, and criminal activities that directly contributed to the dangerous plot to eliminate President Donald J. Trump. According to a Congressional document released by James Comer, RSP-LLC was incorporated on June 25, 2009 — exactly 40 years to the day after the abduction and murder of JMD, just a few miles from the birthplace of Joe Biden.

# 2. Jurisdiction & Standing: Why Butler County Holds the Key

This case connects former President Biden's rhetoric—'Time to put Trump in a bullseye'—with Trump shot in that bullseye, just five days later. The network exposed spans political, financial, and symbolic violence across decades.

Butler County has standing to prosecute because on July 13, 2024, President Trump was nearly assassinated—shot at the center of the Rosemont Seneca Bullseye. A bullet grazed his ear, nearly taking his life. Corey Comperatore, from Butler, PA, was killed while shielding his family. Two other Pennsylvania residents were wounded. This was targeted and coordinated as part of the Rosemont Seneca Corridor. This corridor begins in the north at Rosemont Farms, Franklin, PA (historically the northern anchor), extends south to Boyers—home to Iron Mountain's secret vaults, then Butler—and culminates in Fox Chapel, PA, where a second Rosemont Farms is located.

Secrecy binds this network, and the more we uncover, the more troubling it becomes. This discovery is a grim reminder of how deep and dangerous these forces run, twisting power for their own gain.

The 'Rosemont Seneca Corridor' is tied to Rosemont Seneca Partners (RSP), LLC, founders included Hunter Biden, Devon Archer, and Christopher Heinz in 2009. The name was derived from the Rosemont Farms property in Fox Chapel, inherited by Teresa Heinz-Kerry after the death of her husband, U.S. Senator John H. Heinz III, in a mid-air collision. This connection deepens the ties to Pennsylvania and reinforces the criminal network's foundation in the state, with significant jurisdictional implications for Butler County and the Commonwealth of Pennsylvania.

#### Jurisdictions of Relevance:

Given the nature of this conspiracy, multiple jurisdictions have a stake in the outcome of this case. The following is a non-exhaustive list of locations where related crimes, including financial, political, and criminal actions, were either committed or coordinated:

# 1) Butler County and Surroundings

- **Butler, PA:** On July 13, 2024, President Donald J. Trump was nearly assassinated here, shot in the center of what the Butler Brief proves to be the Rosemont Seneca Bullseye.
- **Fox Chapel, PA:** Home to Rosemont Farms, inherited by Teresa Heinz-Kerry. It serves as the epicenter of Rosemont Seneca Partners (RSP), LLC, a key entity within the Rosemont Network. Rosemont Farms is a pivotal southern waypoint on the Rosemont Seneca Corridor.
- Franklin, PA: Location of yet another Rosemont Farms and a key northern waypoint on the Rosemont Seneca Corridor.

### 2) Commonwealth Communities Impacted by Rosemont Network Activities

- **Beaver County, Butler County, and potentially all counties in PA:** The East Palestine train wreck on 2/3/23 released dioxin and toxic chemicals, verified by AI to be a false flag operation—a 'hat tip' to Hamas—not an accident, but a deliberate act.
- Luzerne County: Wilkes-Barre, the hometown of both Mary Jo Kopechne (MJK) and Joan Marie Dymond (JMD), who were both murdered in the summer of 1969, within 23 days of each other, on either side of the Apollo 11 Moon launch—the dawn of the Space Age—and aligning with the broader patterns of political violence linked to the Rosemont Network. An open and active kidnapping and murder investigation into JMD's death is currently underway at PA State Police Troop P, where preliminary indications suggest the possibility of a double-murder scenario.
- **Rosemont, PA:** Location of potential foul play in the death of Senator John H. Heinz III, which has been speculated to be tied to the actions of the Rosemont Network, Skull and Bones, and other associated entities. Upon his death, Senator John Heinz III willed his 90-acre farm, Rosemont Farms, Fox Chapel, to his widow, Teresa Heinz (Now Teresa Heinz-Kerry).
- Carbon County, PA (Albrightsville, PA): Home to Bryan Kohberger, located 26 miles from Scranton, PA and Moscow, PA. His ties to Biden's sphere and possible connections to the Rosemont Network raise questions about potential brainwashing. Was he a sleeper agent for Biden's CIA?

# 3) States Potentially Impacted by Rosemont Network Activities

- **Massachusetts (MA):** The suspicious death of Mary Jo Kopechne at Chappaquiddick, which should be reinvestigated as a double murder, and coordinated with PA State Police Troop P (currently investigating Joan Marie Dymond's murder). AI analysis reveals Ted Kennedy was not the driver, exceeding the legal threshold for re-evaluating MJK's death as a murder.
- California (CA): The connection between MJK's murder and Charles Manson's "Helter Skelter" murders, 21-days after MJK's death, mirrors a calculated pattern of violence, also seen in the double murder of Joan Marie Dymond, taken 21-days before the moon launch.
- Ohio (OH): The East Palestine train wreck on 2/3/23, crossing the Rosemont Seneca Bullseye in Butler, links this tragic event to a broader conspiracy. Verified by AI as not an accident.
- Idaho (ID): Bryan Kohberger, the confessed killer of four in Idaho, is from Albrightsville, PA, just 26 miles from Scranton—the hometown of Joe Biden. Kohberger later moved across the country to Pullman, WA, which sits just 8 miles west of Moscow, Idaho—the site of the murders. Oddly, Joe Biden was born in Scranton, just 8 miles from a different Moscow—Moscow, Pennsylvania. This eerie alignment between two cities named Moscow, separated by thousands of miles but linked to Biden's political roots and an unknown motive, raises serious questions about ritual geography, symbolism, and potential sleeper cell behavior. Even more alarming: the murders occurred just one day before U.S. Attorney John R. Lausch Jr. was quietly appointed to investigate Biden's handling of classified documents—a bombshell story buried under the bloodshed—and just two days after President Trump announced his 2024 campaign on 11/15/22. Was this massacre timed to protect Biden, and if so—who orchestrated it? Does the *Kohberger Dossier* expose the hidden motive behind the massacre—and prove that Moscow, Idaho, was not just a crime scene, but one more ritual bloodstain on the long trail that finally led to the Trump assassination attempt in Butler, PA?
- New York (NY): Luigi Mangione, a UPenn graduate (home to the Biden Penn Center), is the alleged shooter in a December 4, 2024, Midtown Manhattan assassination exactly 144 days after the Butler, PA, shooting. The number 144, known as a gross, often marks the completion of a ritual cycle. The timing appears deliberate a grotesque celebration of the Rosemont Network's prior success in targeting Trump? Mangione's education at UPenn further implicates the Penn Biden Center as a potential nerve center for planning or indoctrination.

# <u>The Rosemont Seneca Corridor – Trump Shot</u>

On July 8, 2024, just five days before the assassination attempt on President Donald Trump in Butler, Pennsylvania, Joe Biden made a statement that was as chilling as it was intentional: "So, we're done talking about the debate. It's time to put Trump into a bullseye." This was no slip of the tongue—and it wasn't just a metaphor. Biden's words were a coded message to a powerful, long-established network, one that had been operating for decades. This network, based in Pennsylvania with far-reaching global influence, was created to ensure no obstacle ever stood in Biden's way as he sought to secure power. The Rosemont Network heard Biden's call loud and clear, springing into action. The shooting of Donald Trump on July 13, 2024, was no random act—it was the culmination of this calculated effort, as Trump found himself unknowingly trapped in the literal and symbolic crosshairs of the Rosemont Bullseye.

Subsequent to Biden's 'bullseye' statement, additional coded signals circulated in public channels. These signals, though not detailed here for jurisdictional clarity, reinforce the finding that the Rosemont Network operates through symbolic communication intended to incite action.

The origins of this far-reaching network stretch back much earlier, potentially as far back as the founding of Rosemont College in 1901 or even to the construction of Rathalla, the grand estate built in 1851 by (name of original builder). Rathalla has long represented a core of power in Rosemont, PA, serving as the center from which the Rosemont Network has spread its influence.

Interestingly, Rosemont College would later establish its roots on this very land. But the story truly picks up momentum in March 2009. Just two months into his first term as Vice President, Joe Biden saw the Rosemont Estate, located in Wilmington, DE, added to the National Register of Historic Places. Was this a fingerprint of Joe Biden's influence? Was he intentionally waking up the old ghosts of Rosemont, reigniting a legacy of power and influence? Then, in the very next month, April 2009, discussions began that would lead to the formation of Rosemont Seneca Partners, LLC, founded in June 2009 by Hunter Biden, Christopher Heinz (John Kerry's stepson), Devon Archer, and others—with Biden and Kerry playing key roles behind the scenes.

The Rosemont Network's influence runs deep and wide, stretching across Pennsylvania, into other states, and even global power structures. The name "Rosemont" isn't merely a geographical coincidence—it has long been synonymous with wealth, power, and control. At the heart of this network is Rosemont Farms, a 90-acre property located in Fox Chapel, PA, which was inherited by Teresa Heinz after the untimely death of her husband, Senator John Heinz, in 1991. With a net worth estimated at \$750 million, the estate would become a symbol of the family's influence, especially after it passed into the hands of Teresa Heinz-Kerry, who married then-Senator John Kerry [D-MA].

According to Hunter Biden, the name "Rosemont Seneca Partners" was derived from Rosemont Farms in Fox Chapel, located just south of Butler, PA. Interestingly, a second "Rosemont Farms" exists in Franklin, PA, about 60 miles north of Fox Chapel. Both Butler and Boyers lie on what I refer to as the Rosemont Seneca Corridor

But, why "Seneca"?

This corridor seems to have existed long before it was officially branded as such. With Rosemont Farms in the north and another Rosemont Farms in the south, this area has historically been a point of convergence for power. It appears to have been revived, perhaps reawakened, by Joe and Hunter Biden, John Kerry, Christopher Heinz, and others.

Notice in Image #1, Seneca, PA, is just 6 miles east of Franklin. This positions the corridor to pass directly through Butler, cementing the incorporation of Rosemont Seneca Partners, LLC as the first official "crosshair" on what I call the Biden's Butler Bullseye, the Rosemont Bullseye, even the Rosemont Seneca Bullseye. The next chapter in this saga reveals the barbaric actions it took to position the second crosshair on the Biden's Butler Bullseye.

We've just seen the meticulous planning that went into creating the Rosemont Seneca Corridor, forming the north-to-south crosshair of the Biden's Butler Bullseye—the very target Joe Biden referenced when he said, "It's time to put Trump into a bullseye."

Next, let's examine the calculated moves that shaped the west-to-east crosshair of the Rosemont Seneca Bullseye.

# Target Acquisition: The Role of East Palestine in Planning 10/7

The derailment in East Palestine, Ohio, on February 3, 2023, was not just an environmental disaster—it was a signal, a green light for a tragedy that would soon unfold with devastating consequences in a region Aristotle once called 'Eastern Palestine.' The train wreck foreshadowed the Hamas Massacre, which occurred eight months later on October 7, 2023. The toxic, flammable cargo, coupled with the inhumane handling of the event, raised serious questions about what still remains behind the curtain in East Palestine, Ohio.

East Palestine, Ohio, happens to be just one mile over the Ohio border from Pennsylvania and 33 miles west of Butler, PA, the heart of the Rosemont Seneca Bullseye. Interestingly, the derailment occurred just 11 weeks after Trump announced his campaign for a second term in office. This timing further strengthens the connection to the west-to-east crosshair, arming the deadly bullseye, as it were.

The choice of the town named "East Palestine" was also no coincidence. This was a clear symbolic message, deployed at a time of rising tensions with Iran and shortly before the Biden administration authorized the release of \$6 billion in frozen assets to Tehran on September 11, 2023—a date packed with historical and psychological meaning. This date also marked the 100th anniversary of Adolf Hitler's Beer Hall Putsch on 9/11/23 (November 9, 1923, in German date format) and Biden's \$6 billion payout on 9/11/23 (September 11th in U.S. date format).

So, was Joe Biden and the Rosemont Network attempting to rekindle the hatred of Hitler, unleashing the same forces of destruction for the Hamas Massacre, just 26 days later? And did they plan to do it from the White House, of all places?

### The Genetic Signal: 2/3/23 and the 23andMe Hack

The date of the East Palestine train wreck, February 3, 2023 (2/3/23), seems to have been intentionally chosen, carrying an explicit anti-Semitic tone. The number 66, which comes to mind from the date, 2/3/23, calls back to "66" and the year 66 A.D., when the Roman Empire massacred 50,000 Jewish people during the Alexandria Riots. This is no mere coincidence—it appears to be part of a deliberate symbolic framework.

The symbolism doesn't end with geography. The date 2/3/23 can also be interpreted as a genetic cipher—a reference to "23 chromosomes from each parent." So, 23-23 represents the whole genome, of 46 chromosomes, an unsettling connection between the symbolic date, the physical location and genetic data.

And what happened next? In spring 2023, hackers infiltrated 23andMe's genetic database. Then, on October 6—the 50th anniversary of the Yom Kippur War—someone published almost 1 million profiles, primarily of Ashkenazi Jewish descent, on the dark web, where they could not be taken down. Whether operational or symbolic, the leak mirrored the strategic and antisemitic timing of the massacre that followed just one day later.

The day after that breach, Hamas launched its slaughter.

#### Did Hamas target homes using records taken from 23andMe?

This chain of events strongly suggests preparation, targeting, and timing—down to symbolic numbers, historical anniversaries, and biometric warfare. The train derailment in East Palestine, Ohio, on 2/3/23—exactly eight months before the 10/7/23 Hamas massacre—served as a geographical and temporal marker, signaling the operation before it unfolded.

The connection between East Palestine, the 23 and Me hack, and the October 7 massacre is not just circumstantial. It points to a deliberate orchestration of events that spans across geographical boundaries, time zones, and even genetic data. The coordination between these events suggests a highly organized strategy, potentially aimed at exploiting geopolitical tensions and manipulating timing for maximum psychological impact. The train derailment was not a mere accident—it was part of a larger plan, carefully staged, and executed as a prelude to the violence of October 7.


These interconnected events highlight the deeply rooted connections and the potential exploitation of intelligence and technology to facilitate terror. The eerie synchronization of these events is difficult to ignore, raising crucial questions about the manipulation of genetic data and the weaponization of timing.

On **February 3, 2023**, a train derailment in **East Palestine**, **Ohio** triggered a wave of environmental disaster, yet it was more than just a tragic event—it was part of something far bigger. The timing and location of this incident seem too perfectly aligned to be coincidental.

East Palestine, just one mile over the border from Pennsylvania, lies 33 miles west of Butler, PA, the heart of what we refer to as the Rosemont Seneca Bullseye. This event occurred 11 weeks after President Trump announced his campaign for a second term—a notable detail when considering the political and symbolic context. This was no ordinary accident. The East Palestine Train Wreck aligns geographically with Butler and the Rosemont Seneca Corridor. East Palestine anchors the western end of the horizontal line displayed in Image #3, which passes right through Butler, PA, and the Rosemont Bullseye, crossing the first crosshair we made in Image #1. This forms the symbolic center of the Rosemont Network—a calculated and deliberate positioning that demands closer scrutiny.

### Biden's 2020 Pittsburgh Statement – Arming the Bullseye

On August 31, 2020, during a campaign speech in Pittsburgh, Joe Biden compared Donald Trump to segregationist Governor George Wallace—who was shot in 1972 while campaigning for president. Biden used the comparison multiple times throughout the 2020 cycle, stating: "President Trump is more George Wallace than George Washington."

The Wallace remark wasn't just an insult. It was an invocation—planting the idea that Trump, like Wallace, might be too dangerous to let finish his campaign.

Sixteen-year-old Thomas Crooks, living nearby in Bethel Park, may have heard that message. He may have understood the signal.

And just miles away, in Butler County, another future president—George Washington—was nearly assassinated in 1753.

It's not just politics. It's geography. It's prophecy. The Bullseye had been spiritually armed.

### Kimberly Cheatle's Role in Arming the Bullseye – The First Assassination Attempt

In July 2022, Kimberly Cheatle was appointed Director of the U.S. Secret Service, just weeks before the infamous Mar-a-Lago raid on August 8, 2022. This raid, a highly unusual and politically charged action, was authorized under her leadership. It was not just a law enforcement operation; it was a high-risk action that endangered the life of President Trump. This marked the first assassination attempt on Trump's life—a near-fatal escalation that was facilitated by political maneuvering and aided by the absence of a Trump-appointed Secret Service director

Cheatle's leadership failure was not limited to the Mar-a-Lago raid but extended to her role in the 2024 Butler shooting, where Trump's security detail failed at critical moments. As Director, Cheatle enabled an environment where Trump was exposed to unnecessary danger, and the Secret Service's role was compromised. This negligence contributed directly to the Butler shooting on July 13, 2024. Trump was left vulnerable, just as his political opposition, the Biden administration, positioned him as a target in both rhetoric and inaction. The attack in Butler was not random—it was part of a larger, systemic failure to secure Trump, rooted in the same political climate.

Now that we've visualized the connection, let's take a closer look at Image #3.

The location of the East Palestine train wreck on 2/3/23 intersects with Punxsutawney, PA—home of Groundhog Day, which takes place every year on 2/2. With the wreck occurring just one day later, the timing aligns with a symbolic link. East Palestine, Ohio, is only about 33 miles west of Butler, PA, which places it on the western end of the west-to-east crosshair. When extended east, this line reaches Punxsutawney, 60 miles from Butler, creating a west-to-east crosshair through the Rosemont Seneca Corridor, north-to-south.

In fact, the presence of Punxsutawney, with its Groundhog Day tradition, adds another layer of meaning. The town, where a large rodent (or "fat rat") plays a central role in the annual event, may point to more than just a quirky tradition. Speaking of rodents, Rosemont College, located in Rosemont, PA, is home to Rathalla, an

important historical building. In fact, Senator John Heinz III was tragically killed in Rosemont, PA, raising the question—was his death another fingerprint of the Rosemont Network?

With the eastern end of the crosshair anchored, we now move to the critical mathematical analysis that reveals the train wreck wasn't a mere accident. Grok-3's study highlights the statistical improbability of these events happening by chance. The analysis shows how these locations align in a manner that is too precise to be a coincidence.

### Grok-3's Mathematical Findings:

Furthermore, just two months after the train wrecks, the 23andMe data was hacked. The genomes of up to 1 million people of Ashkenazi Jewish descent were published on the dark web—the day before the 10/7 massacre, and on the 50th anniversary of the start of the Yom Kippur War.

Grok-3's study used advanced probability analysis to calculate the odds of these events occurring randomly. The odds were staggering, with the East Palestine train wreck and its geographic alignment to Punxsutawney and Butler coming in at an improbable 1 in 48.6 quintillion. Additionally, we seek urgent action on the shooting of Corey Compatore in Butler County and urge that this tragic event be treated as part of this larger conspiracy.
