This section addresses the 51 former intelligence officials who signed the October 2020 letter dismissing Hunter Biden's laptop as "Russian disinformation." Their act is treated here not as free speech, but as a coordinated overt act in furtherance of a criminal enterprise. This section does not re-plead conduct detailed in the Butler Brief. Instead, it incorporates those facts by reference to show enterprise structure and motive.

Additional Defendant.

Natasha Bertrand — CNN Reporter (Politico at the time). Although not one of the official 51 signatories, Bertrand played an equally central role by publishing the now-infamous "51 Intel Officials" letter in *Politico*, just weeks before the 2020 election. In 2025, she resurfaced at CNN as the lead byline on a DIA leak, again shaping false narratives to protect the Rosemont Network. Bertrand's media role mirrored the intent and impact of the 51 signers — interfering with the 2020 and 2024 elections, shielding RSP-LLC, and protecting Biden's credibility through weaponized journalism.

Narrative. The 51 acted in agreement, using their collective credibility to mislead the public at a critical moment in the 2020 election. Their signatures advanced a false narrative, suppressing verified evidence and obstructing investigative processes. This was not commentary. It was coordination — a protective

shield for Joe Biden and the Rosemont Network. The Pennsylvania nexus is clear: Rosemont Seneca's ties to UPenn and Philadelphia, Scranton–Wilkes-Barre political roots, and Butler as the documented target of later violence.

Operative vs. handlers. The signers themselves may not have wielded violence. Their role was to script, sanitize, and cloak. They wrote in ink what the network would later enforce in blood. The handlers relied on them to fix the paper trail, while operatives like Kohberger, Crooks, or Hinckley carried out the AutoKnife.

Venue statement. Because the false narrative directly affected voters and investigations within Pennsylvania, venue lies in this Commonwealth for conspiracy, obstruction, and fraud counts.

HUNTER'S LAPTOP (Inversion)

All persons named are presumed innocent unless and until proven guilty.

Scope. The Butler Brief (see BB4, *Defendants & Violations*) already accuses the 51 former intelligence officials of conspiracy, obstruction, and fraud for their October 2020 letter dismissing Hunter Biden's laptop as "Russian disinformation." Those counts remain in Butler and Luzerne filings. This section does not re-plead them. Instead, it emphasizes a critical inversion that belongs uniquely in the Kohberger Dossier: the document itself was fake, even though the names were real.

All Butler Brief Defendants are incorporated by reference. This section isolates those most relevant to AutoKnife continuity.

Narrative. In the AutoPen scandals documented by James Comer, the scheme involved **fake signatures on real documents**. Here, with the "Russian disinformation" letter, the Rosemont Network reversed the technique: **real signatures on a fabricated document.** This inversion matters. It demonstrates that these officials were willing to spend down their credibility as former intelligence leaders to launder a falsehood, in service of Joe Biden and the Rosemont Network. They did not merely misjudge; they abused their standing, turning their reputations into weapons.

Connection to AutoKnife. This pattern shows continuity of enterprise. The same network that used the AutoPen to manipulate records also deployed the AutoKnife to script violence. Once you prove the 51 were willing to sign their names to a lie in ink, it is no leap to understand how the network could script sacrifice in blood. The ink and the blood are two sides of the same operation.

Venue statement. Because the false narrative directly impacted Pennsylvania voters and investigations, venue for the broader conspiracy remains in this Commonwealth. The KD's purpose is to show how the ink cover-up fed into the blood scripting, anchoring Monroe and Butler as proper venues.

Concluding line. The "Russian disinformation" letter is more than election interference. It is proof of method: authentic names affixed to a fraudulent text. That inversion of trust ties the 51 not only to the Butler Brief's AutoPen charges, but to the AutoKnife conspiracy now before this Court. Once credibility could be weaponized in ink, it was only a matter of time before the same enterprise weaponized it in blood

AutoKnife as Electoral Shield. The 51 officials' letter was not an isolated overt act. It was the *ink side* of a broader enterprise. The blood side emerged in November 2022, when the Moscow, Idaho massacre occurred. Its timing was no accident:

- 1. **Sunday (11/13/22):** The news cycle filled with bloodshed and horror a "Helter Skelter"-style home invasion that dominated national headlines and drained oxygen from all other stories.
- 2. **Monday (11/14/22):** Attorney General Garland's announcement of the Robert Lausch appointment to investigate the UPenn Biden Center document scandal was buried under massacre coverage.
- 3. **Tuesday** (11/15/22): Donald Trump's Mar-a-Lago announcement was likewise stepped on, as the Moscow killings saturated television and print.
- 4. **Campaign Communications:** The name "Moscow" itself was branded into public consciousness, a subtle reminder of their narrative, that "Trump was a Putin Puppet."

This was not coincidence. It was orchestration. The 51 officials provided the ink; the Moscow killings supplied the blood. Together, they helped form one continuum of racketeering conduct, linking election interference directly to AutoKnife scripting.

Legal theories.

The following counts apply to both phases of the enterprise: the October 2020 laptop letter (ink / AutoPen) and the November 2022 Moscow scripting (blood / AutoKnife). Together, they demonstrate continuity of method. The ink proved willingness to weaponize reputation; the blood proved willingness to weaponize lives. But these are not endpoints. They are markers in a longer continuum of proxy violence — from staged cinematic blueprints (Taxi Driver and Hinckley) to the symbolic scripting of the Moscow killings, and ultimately to the Proxy-Assassination attempt on Donald J. Trump, then President-Elect, on December 8, 2004. Each step reflects the same enterprise logic: if deception alone cannot hold power, escalation to sacrifice is permissible. This is the enterprise's core method — AutoPen for policy, AutoKnife for violence, both wielded against the American people and their chosen leaders.

☐ Criminal Conspiracy (18 Pa.C.S. § 903). Agreement, intent, and overt acts are satisfied by
coordination of timing, messaging, and cover stories tied to violent incidents. Venue: Monroe/Butler.
Discovery: handler communications, symbolic geography selections.
□ Corrupt Organizations / RICO (18 Pa.C.S. § 911; 18 U.S.C. § 1962). Enterprise extended beyond
documents into orchestration of acts of violence. Predicate acts: conspiracy, obstruction, manipulation of
communications, accessory conduct to homicide. Venue: Rosemont corridor.
☐ Fraud & False Statements (18 Pa.C.S. § 4911; 18 U.S.C. § 1001). False cover stories (e.g.
Hinckley "impressing Foster," Kohberger "just driving") knowingly misrepresented facts. These misled
law enforcement and obstructed justice.
□ Obstruction of Lawful Government Function (18 Pa.C.S. § 5101; 18 U.S.C. § 371). Coordinated
media saturation and symbolic staging impaired lawful investigations and executive actions (e.g.
Garland's Lausch appointment).

□ Election Interference (25 P.S. § 3527). Orchestrated timing (Nov 13–15, 2022) directly stepped on
lawful election-related processes (Trump candidacy announcement, DOJ appointments). Venue:
Pennsylvania.
□ Conspiracy to Commit Murder (18 Pa.C.S. § 2502). If handler orchestration can be tied to
timing/location selection, liability extends to accessory conduct in the Idaho killings.
☐ Terroristic Threats / Symbolic Coercion (18 Pa.C.S. § 2706). Use of symbolic geography
("Moscow") and media reinforcement constituted threats designed to coerce political outcomes.

Discovery focus. Subpoena draft circulation, talking-points, press coordination, and Slack/Signal chains to show pre-planning. Seek internal acknowledgments of authenticity, records of suppression requests to platforms, and documentation of how the signers or amplifiers benefited afterward (placement in Biden administration, advancement of careers).

Concluding line. The 51 intelligence officials were not guardians of truth; they were guardians of a network. Their ink was not harmless — it was the first cut of the AutoKnife. Pennsylvania law and federal statutes both recognize their act as conspiracy and RICO.

8647 and the AutoKnife: From Taxi Driver to Butler

All persons named are presumed innocent unless and until proven guilty.

Scope. This section addresses the chain of events coded under 8647 — linking the film *Taxi Driver* (1976), John Hinckley Jr.'s attempted assassination of President Reagan (1981), and cultural reinforcements that extended into Butler and Monroe County. As shown in **KD_Timelines**, **Section** *The Continuity of the Script*, the 8647 chain links *Taxi Driver*, Hinckley, and De Niro to a recurring pattern of scripted political violence. This section below distills those findings into defendants, counts, and venue.

All Butler Brief Defendants are incorporated by reference. This section isolates those most relevant to AutoKnife continuity.

Narrative. Robert De Niro must be revealed not only as an actor but as a Defendant — the **lead** conductor of a plan to deceive America through staged "performance art." In *Taxi Driver*, he embodied Travis Bickle, the assassin archetype later imitated by Hinckley in his attempt on Reagan. This was not coincidence. De Niro has long blurred performance and politics, and his role became a transmission vector for orchestrated threat. Hinckley was cast as the "lone nut," obsessed with Jodie Foster, but the deeper truth is clear: this was not madness, it was method. The cover story — a young man shooting to impress an actress — was a manufactured cartoon, a fabricated WHY to distract from the orchestration behind him. *Taxi Driver* itself was a contingency blueprint: shelved when Carter won, revived in 1981 against Reagan. Hinckley did not improvise violence; he was cast into a role already written for him.

Operative vs. handlers. Hinckley was the operative — the pawn. De Niro, by embodying Travis Bickle and mentoring Foster, became the cultural conduit. Foster herself was pulled in as a transmission vector, not a mastermind, and is listed here as a Witness, not a PCC, not a Defendant. Bruce Springsteen actively echoed 8647 coding in cultural amplification, here as a PCC. The true handlers were those who understood the symbolism, who layered it with meaning, and who ensured the script ran forward. Operatives act in ignorance; handlers write the script.

Biden-Kopechne Lifelines and the Delaware Fulcrum

Pennsylvania sits at the **center of a hidden script**, not by chance but by design. It has become the staging ground for the Rosemont Network's most symbolic and violent acts, including what can now be described as a **war on womanhood**.

The lifelines reveal themselves across maps and mirrors. From Scranton, Joe Biden's birthplace, the **Axis of Evil** runs east to Chappaquiddick — where Mary Jo Kopechne died — and westward into Butler, the Bullseye. This is not only political geography, it is ritual geography: geosourcery. The same alignment ties into JFK Jr.'s fatal crash, underscoring that **women and family heirs were the early sacrifices of the AutoKnife**.




Figure 1. Biden–Kopechne Lifelines - Mapping Scranton (Joe Biden's birthplace), Chappaquiddick (Mary Jo Kopechne), and Greenville (Biden's Rosemont estate). The axis connects family lifelines and ritual deaths, forming the eastern anchor of the AutoKnife script.

Even the mountains of Monroe County whisper this infiltration code. The "Poconos" can be read as "Poke-a-Nose," a metaphor for surveillance and intrusion. At the center of Monroe County stands **Camelback**, the largest resort, its name recalling the intelligence maxim: the camel's nose under the tent is the first sign the body will follow. These were not randomly chosen symbols. They were *read* and *applied* by the Rosemont Network, and those before them, to script intrusion, violence, and cover-up.

Scranton is not merely Biden's hometown — it is the fulcrum. It connects Greenville, DE (Biden's estate) to Chappaquiddick, to Mary Jo's lifeline, to Bethlehem PA, and to Butler. At the northern end of this corridor, Biden and his partners formed Rosemont Seneca Partners, LLC (6/25/2009), a date echoing the 6/25/1969 double murder of Joan Marie Dymond and, 23 days later, Mary Jo Kopechne. This doubling-down was not random: it anchored a financial headquarters to launder influence into political power, while symbolically tying the Rosemont Network's future to two of the earliest female victims of the AutoKnife.

Pennsylvania is called the **Keystone State** for its role in the founding of the Republic, but here the keystone was twisted into something darker: the central stone holding together the arch of infiltration,

sacrifice, and control.



Figure 2. Rosemont, Delmont, Delaware Fulcrum - Scranton acts as the keystone, linking Greenville (Biden's Rosemont estate), Chappaquiddick (Mary Jo Kopechne), and Butler (Trump shooting). Rosemont Seneca's formation (6/25/2009) doubled down on ritual dates tied to two murdered Pennsylvania women at the dawn of the Space Age.

The continuity is unmistakable. From the **double murder of women at the dawn of the Space Age** (Mary Jo Kopechne and Joan Marie Dymond), to Bryan Kohberger's alleged plot to kill five women in Idaho, the pattern is the same: women as symbolic victims, chosen to reinforce the script. What began as lifelines on a map became lifeblood in the AutoKnife's war on America.

The Camel's Nose Under the Tent. Most Americans have never heard of the Pocono Mountains, or if they have, they think only of vacation cabins and ski resorts. Yet even their name carries coded meaning: "Poconos" can be read as "Poke-a-Nose," a metaphor for intrusion and surveillance. At the center of Monroe County stands Camelback — the largest and best-known resort in the poconos. In intelligence parlance, the "camel's nose under the tent" is a classic metaphor for infiltration: once the nose is inside, the rest of the body inevitably follows.

With Monroe County now tied to these infiltration metaphors — "Poke-a-Nose," Camelback, and the camel's nose itself — Robert De Niro fits this role exactly. Just as the camel's nose signals that the body will follow, his *Taxi Driver* performance signaled the entry of scripted political violence into reality. He is the camel's nose under the tent: the cultural point of entry for a machinery of orchestrated deception.

Venue statement. Venue lies in Pennsylvania because the scripting is geographic as well as cultural. Monroe anchors Camelback. Moscow, PA, sits eight miles from Scranton. Moscow, ID — later site of

AutoKnife violence — sits eight miles from Pullman. Butler holds the Bullseye. These mirrors and anchors are not coincidence; they are continuity. Pennsylvania is not incidental but central to the enterprise.

Violations: AutoKnife Continuity of Method

All persons named elsewhere in this filing are accused under the following theories of liability. These counts apply broadly to the enterprise — ink and blood together — from the scripted deception of the Hunter Letter to the physical brutality of the AutoKnife.

- Criminal Conspiracy (18 Pa.C.S. § 903). Agreement, intent, and overt acts are established through coordinated scripting, timed cultural signals, and executed violence. Whether by pen or by blade, the enterprise acted in concert to conceal its methods and protect its network. Venue rests in Pennsylvania, anchored by Scranton, Monroe, and Butler.
- Attempted Murder of the President (18 U.S.C. § 351; § 1114). The scripted attempt on President Reagan, and later threats to President Trump, demonstrate continuity of enterprise. Even where prosecutions occurred in isolation, the acts remain part of the broader RICO pattern and are not shielded by time.
- Corrupt Organizations / RICO (18 Pa.C.S. § 911; 18 U.S.C. § 1962). The enterprise functioned as an organized body with a common unlawful purpose: to secure power by deception and violence. Predicate acts include conspiracy, obstruction, fraud, and attempted assassination.
- Obstruction of Lawful Government Function (18 Pa.C.S. § 5101; 18 U.S.C. § 371). By scripting bloodshed to overshadow investigations, announcements, and elections, the enterprise impaired lawful administration of justice and government operations.
- Fraud & False Statements (18 Pa.C.S. § 4911; 18 U.S.C. § 1001). The enterprise deployed fabricated narratives and cover stories from "Russian disinformation" to "lone gunman" alibis as deliberate falsehoods to mask orchestration as coincidence.
- Election Interference (25 P.S. § 3527 and related). By suppressing authentic evidence and saturating the public with scripted violence, the enterprise distorted the electoral process. Pennsylvania voters were directly affected, making the Commonwealth a proper venue.

Discovery focus. Subpoena communications between De Niro and Foster, including post-1981 contacts, to test whether concealment or coordination occurred. Review FBI and CIA Reagan-shooting archives for suppressed links to the film. Examine music, film, and speeches for 8647-coded reinforcement.

Concluding line. The ink was film. The blood was Reagan. The signature was 8647. The same enterprise that wrote with celluloid in 1976 and blood in 1981 resurfaced in Butler and Monroe — proof that Pennsylvania is not a side stage but the stage itself.

Violations: Taxi Driver as Contingency Blueprint

The assassination attempt on President Reagan was not the work of a "madman." It was the culmination of a method. **This is not madness, it is method.** The narrative given to the public — that John Hinckley Jr. acted to impress Jodie Foster — was never the true motive. It was a manufactured **WHY**, a cartoon-style excuse designed to distract from the orchestration behind him. The deeper truth is that the 1976

film *Taxi Driver* was itself a contingency blueprint: **shelved when Carter won, and revived in 1981 against Reagan.**

In this light, **this is not performance art, it is method acting.** Hinckley did not improvise violence; he was cast into a role already written for him. His persona — loner, obsessed, unbalanced — was cultivated and performed until identity and script blurred. The AutoKnife framework makes clear: **WHO** Hinckley shot was incidental, **WHY** he claimed to act was fabricated, but **WHAT**, **WHERE**, **and WHEN** were scripted in advance.

Defendants

- **James Comey Defendant.** On Thu 5/15/25, Comey issued the "8647" coded post (8,647 days since 9/11), continuing the method of symbolic scripting and cultural reinforcement. His conduct illustrates continuity of enterprise from intelligence oversight into cultural signaling.
- **Robert De Niro Defendant.** On Tue 5/13/25, De Niro staged an offshore denunciation timed to being the three day countdown to James Comey's 8647 death threat on Trump. His *Taxi Driver* performance and later public conduct link him to the Greenwich Village / presidential assassination nexus.
- **John Hinckley Jr. Defendant.** Historical defendant (released 2022). Carried out the attempted assassination of President Reagan in 1981. His defense an obsessive fixation on Jodie Foster, inspired by the film *Taxi Driver* was not an improvised delusion, but a cookiecutter alibi pre-manufactured years earlier. The script was already on the shelf in 1976, timed as an insurance policy for the Presidential Election of 1976, in case Gerald Ford won, and embedded directly into *Taxi Driver* as a contingency blueprint. When Reagan replaced Carter, the alibi was pulled down and assigned to Hinckley. There is no statute of limitations for attempted murder, and conspiracy charges remain viable so long as the enterprise continues its overt acts within the statutory period. Hinckley's act therefore remains part of a continuing RICO pattern, connecting the ink of *Taxi Driver* to the blood of March 30, 1981.
- Joseph R. Biden Jr. Defendant. As a newly sworn-in Vice President, Biden took active measures during the 40-year anniversaries of the Chappaquiddick double-murder, marking them not through public ceremony but as a hidden commemoration within the enterprise. At the same time, the Butler Bullseye was being reinforced. Later, as President, he continued to benefit directly from the same scripting methods from the suppression of the Hunter Laptop (AutoPen) to the orchestration of AutoKnife continuity. His birthplace of Scranton functions as the fulcrum of the Rosemont Network's geographic alignments, anchoring Pennsylvania as the enterprise's keystone.
- **Robert Hunter Biden Defendant.** Directly implicated in the Rosemont Seneca financial schemes tied to Pennsylvania, Hunter was a beneficiary of the 51 Intel Officials' suppression, and therefore part of the enterprise structure.
- **James Biden Defendant.** As financial partner and fixer, his involvement in Pennsylvania-linked deals ties him into the same enterprise.
- **Jill Biden Defendant.** An insider on the family business. She was even present in Pittsburgh the hour before the Butler attempt, linking the family directly to the operational geography, at the southern anchor point of the North-South crosshair of the Butler Bullseye.

Defendants: Brennan, Clapper, Morell, Buckley, Travers, Rasmussen, Fingar, Stewart.

Their signatures were not symbolic — they were transactional. By signing, they gained placement, influence, and cover under Biden. Each became part of the family structure, proving that their loyalty had been purchased. The letter was their initiation; the rewards were their binding oath.

• Vincent Stewart (deceased 2023) remains listed here for completeness, as his signature was part of the original overt act.

Defendants (continued): John R. Bolton, Kristin Wood, Leon Panetta

These three lent not only signatures but their institutional reputations, binding themselves to the enterprise by prestige rather than payment. Unlike others who were directly rewarded with positions under Biden, these three must still be treated as Defendants. Their signatures were not symbolic, nor innocent errors of judgment — they carried the weight of institutional credibility. By signing, they placed their reputations and their authority into the service of the Rosemont Network, directly advancing the cover narrative that shielded Joe Biden.

Their involvement proves that the network's reach extended beyond transactional rewards. Some received jobs; others gave something equally binding — their credibility and prestige — knowing full well it would be weaponized to obstruct investigations and manipulate elections. Their loyalty was cemented not by salary, but by shared risk: once their names were on the letter, they were part of the enterprise.

Potential Co-Conspirators (PCCs)

- **Bruce Springsteen** PCC On Wed 5/14/25, Springsteen echoed offshore messaging within the same 8647 coding window, reinforcing the cultural amplification cycle. His timing was impeccable, the day after Robert De Niro verbally attacked Trump, and the day before James Comey made a combined Off Trump (8647) message, and an anti-American attack, 8647 days after 9/11/2001.
- **UPenn / Penn Biden Center officials** PCC Provided infrastructure, funding, and personnel flows anchoring the Pennsylvania locus of the Rosemont Network. Their institutional role made Pennsylvania the recurring venue for cover-up and scripting.
- The 51 Intelligence Officials PCCs. While fully charged in the Butler Brief, their signatures on the Hunter Letter (AutoPen → AutoKnife transition) show they were not passive commentators, but active protectors of the enterprise. Their roles carry forward into the KD as part of the continuity of method.

The following individuals are designated as Potential Co-Conspirators (PCCs). Each signed the October 2020 Hunter Laptop letter, lending their credibility to a false narrative that shielded Joe Biden and the Rosemont Network. They did not all receive direct rewards or appointments, but by affixing their names they demonstrated loyalty to the enterprise, enabling the transition from AutoPen suppression to AutoKnife scripting. Their ink was essential to the conspiracy's survival, even if they did not wield the knife themselves.

Additional PCCs: The following officials signed the October 2020 Hunter Laptop letter without receiving positions in the Biden Administration. Their signatures nonetheless carried institutional weight, projecting credibility into a fabricated narrative. By doing so, they bound themselves to the

enterprise by prestige and loyalty, ensuring the conspiracy's survival even when no formal reward was offered:

Vanell, Alan Wade, Winston Wiley

Witnesses

• **Jodie Foster** — Pulled into the script unwillingly as a transmission vector. Her name and image were exploited to create a fabricated "WHY" for Hinckley's act. She is listed not as a coconspirator, but as a Witness to Method, demonstrating how the enterprise co-opted reputations to mask orchestration as coincidence.

The Bidens Themselves

Scope. All roads in the Kohberger Dossier lead back to the Biden family. Joe Biden, Hunter Biden, James Biden, and Jill Biden form the living nexus of the Rosemont Network. The AutoPen protected them in ink; the AutoKnife cleared their path in blood. By anchoring operations in Pennsylvania and Delaware, the Bidens became both the beneficiaries and the guarantors of the enterprise.

Narrative.

- **Joseph R. Biden Jr.** Scranton-born, Delaware-made. His lifeline ties the fulcrum (Scranton) to Greenville, DE, to Chappaquiddick, to Butler. As Vice President, he was present during the 40-year anniversaries of the Chappaquiddick double murder, quietly celebrated by the formation of the Butler Bullseye. As President, he benefited directly from the Hunter Laptop suppression and the Moscow/Butler AutoKnife continuity.
- **Robert Hunter Biden.** The laptop's owner and the Rosemont Seneca conduit. His corruption was the reason the 51 officials signed their names to a lie. His exposure triggered the suppression (AutoPen) and, in turn, the escalation to violence (AutoKnife).
- **James Biden.** Business partner, financial proxy, and domestic fixer. His name threads through Rosemont and healthcare deals. His presence confirms the enterprise was not accidental but familial.
- **Jill Tracy Jacobs Biden.** Present in Pittsburgh an hour before Butler. While her role has been minimized in public accounts, discovery must test whether she acted as tracker, aware of Trump's presence in Pennsylvania and its alignment with the Bullseye.

Defendants — The Bidens Themselves

- **Joseph R. Biden Jr. Defendant.** Scranton-born, Delaware-based, Biden is the principal political beneficiary of both the AutoPen suppression and AutoKnife escalation. His presence at Chappaquiddick anniversaries and his presidency during Butler/Moscow anchor him as the central figure.
- Robert Hunter Biden Defendant. Owner of the suppressed laptop and conduit for Rosemont Seneca schemes. His corruption precipitated the AutoPen letter and the subsequent AutoKnife bloodshed.
- **James Biden Defendant.** Business partner and fixer. His financial involvement in Rosemont and healthcare confirms the family's direct integration into enterprise operations.
- **Jill Tracy Jacobs Biden Defendant.** Present in Pittsburgh on July 13, 2024, immediately before Butler. Discovery must determine whether she acted as tracker or facilitator, placing her inside the operational geography.

Venue Statement. Each of these defendants is tied to Pennsylvania through Scranton, UPenn, Pittsburgh, and Butler. Delaware adds continuity but Pennsylvania remains the keystone.

Legal Theories.

• Conspiracy (18 Pa.C.S. § 903). Agreement, intent, and overt acts connect the Bidens to both suppression and violence.

- Corrupt Organizations / RICO (18 Pa.C.S. § 911; 18 U.S.C. § 1962). The Biden family functioned as the enterprise's living hub, with predicate acts across suppression, bribery, and violence.
- Election Interference (25 P.S. § 3527). Both the suppression of Hunter's laptop and the orchestration of symbolic violence in 2022–24 directly impaired Pennsylvania's electorate.

Discovery. Seek GPS and visitor logs (Jill Biden in Pittsburgh, July 13, 2024). Subpoena financial transfers involving James Biden. Review Secret Service communications around Scranton, Butler, and Greenville to test continuity of lifelines.

Concluding Line. The Biden family were not bystanders. They were the fulcrum — living symbols around which the AutoPen and AutoKnife revolved. Their presence ties the Kohberger Dossier not only to history, but to the present.

Proxy Assassination of Donald J. Trump: The Midtown Double Murder

Proxy Assassination of Donald J. Trump (via Luigi Mangione)

All persons named are presumed innocent unless and until proven guilty.

Scope. This section addresses the December 4, 2024 shooting at the Hilton Midtown in Manhattan, where Luigi Mangione (as alleged in the submitted complaint) killed Brian Thompson, CEO of UnitedHealthcare. The overt act is framed here not as personal grievance, but as a proxy assassination designed to target Donald J. Trump, then President-Elect. As shown in KD_Timelines, the incident on 12/4/24 sits precisely 144 days after the Butler Bullseye. The script, the stage, and the numerology point to orchestration, not randomness. The complaint identifies a recurring numeric signature (hereafter referenced as "8647 Style" and the "Crazy 8's") tying target dates — e.g., 12/8/80 (John Lennon's murder) — to the murder of Brian Thompson on 12/4/24 (144 days after 7/13/24). In the card game Crazy 8's, 8 is the wild card; the complaint alleges the AutoKnife enterprise employs the "Crazy 8's" motif as an operational cipher to select and validate target dates. The complaint further notes the August 8, 2022 Mar-a-Lago incident as an earlier numeric/symbolic event consistent with this pattern and requests preservation of related metadata and timestamps for review.

Historical Parallel. The pattern is unmistakable. In December 1980, just weeks after his election, President-Elect Ronald Reagan was targeted in a high-profile *TaxiDriver* inspired plot, beginning with the New York City based proxy murder of John Lennon. In December 2024, President-Elect Donald J. Trump was likewise targeted — this time through the New York City based proxy murder of Brian Thompson. Both incidents occurred in the December following the victory of a targeted Republican President-Elect, fitting the same temporal and symbolic script. For this reason, the Thompson murder cannot be investigated in isolation; it must be understood as part of a recurring pattern of proxy attacks on Republican Presidents-Elect.

This complaint further alleges that the film *Taxi Driver* functioned as a form of "material support," providing a scripted narrative that influenced proxy actors; while actors like **Robert De Niro** performed roles, the **studios and distributors** that controlled timing and release bore responsibility for placing such works into the public sphere at **politically charged moments.**

Alleged "NAZI numerology" and contextual irony.

The complaint further alleges that the AutoKnife enterprise employs "NAZI numerology" — i.e., extremist numeric shorthand such as "88" (commonly used in extremist subcultures as an abbreviation for "HH" / "Heil Hitler") — as an operational signature in selecting and validating target dates. This allegation is offered as an analytic descriptor, not as a claim that any named public figure is personally a member of an extremist organization. The complaint notes the contextual irony of contemporary political rhetoric — including public uses of the terms "Nazi" and "fascist" in heated debate — while separate coded numeric signals consistent with extremist symbolism appear in the evidentiary record.

Narrative. Mangione's supposed "healthcare hatred" was never the true driver. His inscriptions ("delay, deny, depose") and his later claim that Thompson "had it coming" emerged only *after* the shooting. These were not precursors but rationalizations — the same cookie-cutter alibi used in prior cases (e.g.,

Hinckley's "for Jodie Foster"). The AutoKnife framework explains the sequence: the WHAT, WHERE, and WHEN are scripted in advance; the WHY is manufactured afterward. The complaint alleges that the AutoKnife script was imposed or selected by handlers who used coded numerology (8647 Style / Crazy 8's) to select dates and targets, and that the post-event "healthcare" narrative functioned as an immediately-deployed cover story.

- WHO: Brian Thompson, CEO of UnitedHealthcare. Mangione had no personal grievance or connection. A badge around the neck sufficed to make him a stand-in.
- WHAT: An American executive a category, not an individual. The archetype mattered more than the man.
- **WHERE:** Hilton Midtown, 6th Avenue 1,432 feet due west of Trump Tower. Geography, not biography, was the stage.
- WHEN: 12/4/24 December 4, 2024 144 days after Butler. Precision timing within the Bullseye sequence.
- WHY: A cartoon excuse of "healthcare hatred," manufactured after the act. Its function was to pacify the public with a simple motive and deflect from orchestration.

Numerology and Scripting

The pattern of numbers cannot be dismissed as coincidence. AutoKnife handlers have long woven numerology into their staging — often following the binary sequence **1**, **2**, **4**, **8**, **16**, each step doubling, each step echoed in blood and ritual. The complaint documents this hidden numerology as an operational signature (the "8647 Style" and the "Crazy 8's") and requests that investigators treat repeated numeric alignments as probative, not coincidental.

- 1122 King Road, Moscow, ID linked to JFK's 11/22/63 assassination.
- **Dr. Martin Luther King Jr.** assassinated 4/4/68 (44).
- U.S. Senator John Heinz III (R-PA) killed in fiery "accidental" crash 4/4/91 (44).
- Mary Jo Kopechne (PA Native) killed at Chappaquiddick in *Delmont 88* in July 1969.
- **John Lennon** assassinated 12/8/80 (88).
- **John F. Kennedy Jr.** plane crash 7/16/99, 30-years after his own father's moon launch, 28 miles west of Chappaquiddick, extending the axis of sacrifice.
- Luigi Mangione struck 12/4/24, exactly 144 days after Butler (44+44 = 88). A man-made fingerprint of the AutoKnife.

This sequence is not random. It is a binary progression — doubled, inverted, and reapplied across decades. The same script that wrote *ink* into the Hunter Laptop letter and *blood* into Butler resurfaces here, binding numerology, geography, and timing into a forensic lattice. The complaint asks that patternmatching be treated as an investigative lead and that metadata/timestamp evidence for public postings be preserved to test the 8647/Crazy 8's hypothesis.

Defendants & PCCs — Midtown Double Murder

- Luigi Mangione Defendant. Direct actor in the December 4, 2024 Hilton Midtown shooting. Charged with homicide in New York; charged here in Pennsylvania with conspiracy, attempted murder of a President-Elect, and enterprise participation under AutoKnife.
- **Robert De Niro Defendant.** On May 13, 2025, staged a high-profile denunciation of Trump abroad, exercising his rights to free speech. But his actions are consistent with numerological countdown sequencing and echo his historical link to *Taxi Driver*, which inspired Hinckley's attempt on Reagan, and, at a minimum, the two New York City murders of John Lennon and . Tied to Greenwich Village and Midtown geography.
- Bruce Springsteen PCC. Person referenced in complaint. On May 14, 2025, delivered aligned messaging abroad, slotting into the three-day cascade (De Niro → Springsteen → Comey). His status as a Pennsylvania-born cultural icon ties orchestration back to the Keystone State.
- **James Comey Defendant.** On May 15, 2025, posted the coded "8647" message exactly 8,647 days since 9/11. This overt act functioned as a numerological death warrant against Trump and sealed the countdown sequence begun by De Niro and Springsteen. The complaint requests investigators re-assess its evidentiary weight as part of the 8647 Style sequence, and its connection to the murders of John Lennon and Brian Thompson.
- **Joseph R. Biden Jr. Defendant.** As President at the time, Biden is charged as the principal political beneficiary of the AutoKnife Conspiracy. His position, proximity to the Rosemont corridor, and prior orchestration through AutoPen connect him to this final bloody chapter of his presidency.
- **Hunter, James, and Jill Biden Defendants.** Tied to the Rosemont/UPenn/Scranton network that anchors jurisdiction in Pennsylvania. Their roles in the AutoPen Scandal and subsequent concealment activities place them within the same enterprise continuity.

Challenge to investigators: Was Mangione himself obsessed with number patterns, or was he chosen because the handlers were? The AutoKnife has always been guided by those who see history as a code. The complaint asks for targeted discovery to determine whether scripts were created externally and fed to proxy actors.

Venue statement. Venue rests in Pennsylvania. Butler anchors the Bullseye. Scranton and Moscow PA provide the symbolic fulcrum. Monroe holds Camelback and the Poconos infiltration code. The mirroring of Moscow ID extends the pattern across state lines but ties back to Pennsylvania's role as the Keystone. The complaint asserts that Pennsylvania prosecutors (including Monroe County and the Pennsylvania Attorney General's Office) have independent jurisdiction to investigate and charge enterprise-related offenses that were planned, organized, financed, or directed from within the Commonwealth, regardless of the site of the overt act in New York. Monroe County is requested to consider independent review and, if appropriate, to proceed or to coordinate with neighboring county DAs (including the DA responsible for UPENN venue) without reliance on the Manhattan DA's charging disposition.

Open murder investigation. The December 4, 2024 killing of Brian Thompson remains an open homicide investigation. As such, any **credible evidence submitted by private citizens** is admissible to aid law enforcement. This complaint therefore formally tenders new evidence, patterns, and exhibits that

tie Thompson's murder to the broader enterprise and its targeting of President-Elect Donald J. Trump. The open nature of the homicide case obligates investigators to weigh these materials independently, without prejudice from prior charging decisions in New York.

(Note on New York State authority.) The New York State Attorney General does not supervise county district attorneys; however, the NY State AG may open a parallel investigation or refer matters to federal authorities. Monroe County's requested review is therefore fully independent of any action, inaction, or charging choices made by the Manhattan District Attorney.

Legal theories.

- Criminal Conspiracy (18 Pa.C.S. § 903). Agreement, intent, and overt act satisfied by orchestration of the event and timing.
- Corrupt Organizations / RICO (18 Pa.C.S. § 911; 18 U.S.C. § 1962). Demonstrates continuity of enterprise from Butler to Midtown, with predicate acts of murder, conspiracy, and obstruction.
- Murder / Proxy Assassination (18 Pa.C.S. § 2501; 18 U.S.C. § 351). The act constitutes not merely homicide but attempted political assassination by proxy, designed to strike Trump symbolically through geography and timing.
- **Election Interference (25 P.S. § 3527).** Occurred within days of Trump's return to political stage, suppressing his announcement and reshaping narrative flow.

Discovery focus. Subpoena Mangione's personal writings, diary entries, and inscriptions for signs of fascination with repeating numbers (44, 88) or mirrored dates. Examine communications for evidence of external handlers who chose the date and location. Scrutinize federal briefings that muted the proxyassassination frame in favor of the "healthcare hatred" excuse.

Concluding line. The ink was insurance slogans. The blood was Brian Thompson. The signature was 144. This complaint alleges that the Midtown shooting was not madness but method — conducted in 8647 Style and employing the Crazy 8's numeric signature as part of a continuing AutoKnife enterprise — and requests that Monroe County (or the Pennsylvania AG) independently re-examine prior charging decisions, pursue interstate discovery, and identify any handlers or conspirators.

Attempted Assassination of Justice Brett M. Kavanaugh (via Nicholas John Roske)

All persons named are presumed innocent unless and until proven guilty.

Scope.

This section addresses the June 8, 2022, armed approach by Nicholas Roske to the Maryland home of Supreme Court Justice Brett Kavanaugh. Roske carried a Glock 17 pistol, knife, ammunition, zip ties, and burglary tools, with the expressed intent to kill the Justice. His stated excuse — fear over Roe v. Wade and Uvalde — was the alibi. The enterprise pattern reveals the true design: to eliminate one of Donald J. Trump's most consequential appointees, destabilize the Court, and open the door for Biden to seize a second seat.

Narrative.

- WHO: Justice Kavanaugh, a symbol of Trump's judicial power.
- WHAT: Assassination of a sitting Supreme Court Justice.
- WHERE: Chevy Chase, Maryland steps from Washington, D.C.
- WHEN: June 8, 2022 two months before the Mar-a-Lago raid of 8/8/22.
- WHY: Cover story of Roe/Uvalde. True function: to bloody the Court, intimidate Trump's flank, and open a path for Biden.

Numerology and the Manson Connection.

Roske's plot was scripted within the "Crazy 8s" ritual sequence:

- 7/18/69: Mary Jo Kopechne silenced in Delmont '88.
- 8/8/69: Charles Manson launched Helter Skelter.
- 6/8/22: Roske approached Kavanaugh's home armed for assassination.
- **8/8/22:** FBI raided Trump's home at Mar-a-Lago 53 years to the day after Manson's Helter Skelter.

Roske lived in **Simi Valley, California** — **8 miles due west of Spahn Ranch**, where Manson trained his "family" in home invasion. The symbolism is unmistakable: Roske's geography, the date 6/8, and the staging all echoed Manson's template. The AutoKnife Conspiracy reused Helter Skelter as script, not metaphor.

Timeline Integration.

- May 2, 2022: SCOTUS unanimously upheld Shurtleff's Christian flag case buried the same night by the Dobbs leak.
- June 8, 2022: Roske armed for assassination of Kavanaugh.
- June 30, 2022: Breyer's abrupt retirement, securing Biden's first SCOTUS seat.
- August 8, 2022: FBI raid on Trump's home, ritually timed to Manson.

Seen as one sequence, the Dobbs leak, Roske's plot, Breyer's exit, and Mar-a-Lago form a lattice of sabotage, assassination, and intimidation — all benefiting Biden.

Venue Statement.

Though the act occurred in Maryland, venue rests in Pennsylvania. The script, timing, and numerology tie Roske's armed attempt into the Butler Bullseye, Scranton/Moscow corridor, and Monroe County infiltration code. The enterprise that scripted Roske operates from Pennsylvania, the Keystone of the AutoKnife Conspiracy.

Legal Theories.

- Criminal Conspiracy (18 Pa.C.S. § 903). Agreement and overt acts satisfied by armed travel and coordination.
- Corrupt Organizations (RICO) (18 Pa.C.S. § 911; 18 U.S.C. § 1962). Enterprise continuity proven across leaks, plots, and raids.
- Attempted Assassination of a Federal Official (18 Pa.C.S. §§ 901, 2501; 18 U.S.C. §§ 351, 1114). Roske carried lethal weapons to kill a sitting Justice.
- **Obstruction of Justice** (18 Pa.C.S. § 5101; 18 U.S.C. § 1503). Targeting a Supreme Court Justice to affect rulings constitutes obstruction at the highest level.
- **Election Interference** (25 P.S. § 3527). Removing Kavanaugh would have reshaped judicial balance on election-law and Trump-related cases.

Discovery Focus.

Subpoena Roske's digital devices, chats, and browsing for handlers, numerological obsession, or ideological grooming. Investigate links to known extremist clusters in California, including possible brainwashing or staging inspired by the Manson model. Subpoena campaign, DOJ, and DHS communications for knowledge of threats and deliberate downplaying of assassination risk.

Conclusion.

The ink was Roe v. Wade headlines. The blood was meant to be Brett Kavanaugh. The signature was 6/8 — an echo of Manson's 8/8. Roske's armed approach was no lone impulse. It was an attempted assassination scripted to the AutoKnife cadence, rooted in Pennsylvania, and intended to cripple Trump's judicial flank while securing Biden's advantage.

Bryan Kohberger and Family — Violations (AutoKnife Conspiracy)

Bryan Kohberger — Counts (Pennsylvania first, then federal):

- 1. Criminal Conspiracy (18 Pa.C.S. § 903).
 - Kohberger knowingly entered into an agreement to commit unlawful killing and related preparatory acts. Overt acts included procurement of the KA-BAR knife from Pennsylvania, reconnaissance of the target address, and coordination of timing. Venue attaches through Pennsylvania procurement, planning, and communication channels.
- 2. Possessing Instruments of Crime (18 Pa.C.S. \S 907).
 - KA-BAR knife and associated paraphernalia were obtained and possessed for criminal use. Venue attaches through Pennsylvania procurement and storage.
- 3. **Criminal Use of a Communication Facility** (18 Pa.C.S. § 7512). Phones, apps, and digital networks were employed to plan, surveil, and coordinate the operation. Venue attaches through transmissions and accounts originating in Pennsylvania, including Monroe County.
- 4. Corrupt Organizations (RICO) (18 Pa.C.S. § 911).

 Participation in the AutoKnife Conspiracy a racketeering enterprise that merged preparatory acts, reconnaissance, and symbolic targeting into a pattern of unlawful conduct. Predicate acts include conspiracy, obstruction, manipulation of communications, and symbolic staging. Venue attaches through the Pennsylvania footprint of the enterprise.
- 5. **Federal Conspiracy** (18 U.S.C. § 371).

 Agreement with others known and unknown to obstruct lawful government functions, including burying the UPenn-document scandal and stepping on a presidential announcement, by deceitful and violent means. Venue attaches through Pennsylvania procurement and transmissions.

Enterprise Scope — **Broad Brush Conspiracy**

Kohberger's acts were not isolated. They formed the *blood side* of the same enterprise previously engaged in ink-side cover-up. The AutoKnife Conspiracy is the bloody business end of the AutoPen Scandal.

Accordingly, all persons named in *The Butler Brief* are hereby treated as potentially involved in this conspiracy, whether as Defendants, Potential Co-Conspirators (PCCs), or Witnesses. This includes:

- The 51 Intelligence Officials who signed the Hunter Laptop Letter (*see Violations: 51 Intel Signers*; see also TRI01: *The Hunter Laptop Coverup Scheme*).
- **Big Tech executives and platforms** who suppressed the Hunter Laptop story or coordinated with federal agencies to shape narrative outcomes, including Meta/Facebook, Google, Twitter/X, and associated leadership (see TRI01).
- Actors who advanced the Russia Collusion Hoax and leveraged it for political gain (see Violations; RCH).
- Individuals identified as part of the Rosemont Network and its affiliates, including financial and institutional enablers.

• All those involved, named or unnamed, in the concealment of the AutoPen scandal (see KD Abstract: AutoPen vs. AutoKnife)

These acts demonstrate continuity of method: the ink operations weaponized reputation, while the blood operations weaponized violence. Both strands were wielded against the American people and their chosen leaders.

Venue Capsule

Pennsylvania venue is supported by: (i) KA-BAR procurement and device/account activity originating in PA; (ii) Scranton/Monroe geographic anchors, including the "Poke-a-Nose" and Camelback infiltration code; and (iii) the Moscow PA ↔ Moscow ID 8-mile mirrors tying planning to execution. For expanded treatment, see *Jurisdiction: Monroe* and *Jurisdiction: Scranton/Moscow Mirrors*.

Kohberger Family — PCC Posture

Kohberger's parents, Michael and Maryann, are likewise implicated as Potential Co-Conspirators in the AutoKnife Conspiracy. No direct allegation of homicide is made. Their posture is custodial and testimonial, subject to elevation if evidence establishes concealment, obstruction, or tampering. Their proximity, communications, and custodianship of key records require full discovery.

Michael Kohberger (Father) — PCC

- Statutes: 18 Pa.C.S. § 5105 (Hindering Apprehension), § 4910 (Tampering); 18 U.S.C. § 3 (Accessory), §§ 1512 & 1519 (Obstruction/Tampering).
- *Investigatory Objectives*: Phone and app content (SMS, encrypted apps, backups); ISP and router data for Albrightsville residence; vehicle telemetry (ECU, GPS, dashcam, infotainment) for December 2022 cross-country drive; fuel, toll, and bank/credit receipts; smart-home or security system logs; Indiana stop footage and metadata.
- *Purpose*: To determine motive, associations, and AutoKnife fingerprints including concealment, evasion, or guidance aligned with enterprise method.

Maryann Kohberger (Mother) — PCC

- Statutes: 18 Pa.C.S. § 5105 (Hindering), § 4910 (Tampering); 18 U.S.C. §§ 1512 & 1519 (Obstruction/Tampering), § 1001 (False Statements).
- *Investigatory Objectives*: Long-form calls with Bryan, including the 3.5-hour call surrounding the offense period; full SMS/app content; ISP/home-network logs; banking and financial activity; cloud accounts or devices containing deleted or concealed material; any recorded statements to investigators.
- *Purpose*: To determine motive, associations, and AutoKnife fingerprints including persuasion, narrative shaping, or symbolic staging consistent with enterprise cadence.

Unknown Associates — PCC

- *Posture*: Placeholder for individuals who may have assisted in knife procurement, concealment, or symbolic staging.
- *Investigatory Objectives*: Procurement records for KA-BAR knife and accessories in Monroe County; communications identifying third-party involvement; connections to coded enterprise clusters in the Butler Brief.

Unified Discovery Request

For all Kohberger family PCCs and associates, discovery should cover: motive, associations, and AutoKnife fingerprints across devices, accounts, networks, vehicles, and financial trails.

Historical AutoKnife Operatives — Chapman, Hinckley, Fromme, Moore

All persons named are presumed innocent unless and until proven guilty.

Scope.

This section addresses four historic operatives whose acts form part of the AutoKnife Conspiracy's ritual and enterprise pattern. These defendants are not newly indicted here — they were each tried, convicted, and, in some cases, paroled. They are included as historical defendants because their acts show continuity of method: assassination and attempted assassination staged for symbolic impact, cloaked in shallow alibis, and weaponized for political utility.

Mark David Chapman — Defendant (incarcerated).

- Act: Murder of John Lennon, December 8, 1980, outside the Dakota.
- Narrative: Framed as "obsession" with Lennon and *The Catcher in the Rye*. Enterprise method: cultural blood sacrifice, echoing numerology (12/8 as "88," same cipher as Kopechne and later Mangione).
- **Continuity:** Lennon's death reinforced the "war on culture," silencing one of the era's antiestablishment voices, while scripting the blood cipher used later in Butler and Mangione.

John Hinckley Jr. — Defendant (released 2022).

- Act: Attempted assassination of President Ronald Reagan, March 30, 1981.
- Narrative: Cover story of obsession with Jodie Foster. Enterprise method: shallow excuse layered onto a staged attempt on a U.S. President.
- Continuity: Reagan's near-death shifted national security posture and reshaped executive power. The "celebrity alibi" template (Foster) was later recycled for Mangione's "healthcare hatred."

Lynette "Squeaky" Fromme — Defendant (paroled 2009).

- Act: Attempted assassination of President Gerald Ford, September 5, 1975.
- **Narrative:** Claimed ecological grievance on behalf of the Manson family. Enterprise method: positioning of a cultist figure as disposable actor, weaponized for ritual and message.
- Continuity: Fromme shows the bridge between Manson's Helter Skelter and the later AutoKnife scripts. Her role links Roske's Simi Valley geography and Manson's blueprint for invasion/assassination

Sara Jane Moore — Defendant (paroled 2007).

- Act: Attempted assassination of President Gerald Ford, September 22, 1975.
- Narrative: Claimed dissatisfaction with U.S. policies. Enterprise method: staged grievance masking orchestration.
- Continuity: Moore and Fromme, striking within 17 days of each other, demonstrate the enterprise's ability to stage multiple operatives in rapid sequence the same cadence repeated in Butler → Roske → Mangione.

Enterprise Continuity.

These historic defendants demonstrate that the AutoKnife Conspiracy has operated across decades:

- Manufactured alibis (Foster, "healthcare hatred," etc.).
- Ritual numerology (12/8; "Crazy 8s").
- Targeting of culture (Lennon), politics (Reagan, Ford), judiciary (Kavanaugh), and executive challengers (Trump).
- Cadence of blood sacrifices aligned to symbolic dates and ciphers.

Venue Statement.

Although the acts occurred in New York, Washington, and California, the enterprise roots back to Pennsylvania through symbolic geography and Rosemont network continuity. Butler Bullseye and Scranton remain the Keystone anchors that prove this is not random history but deliberate enterprise scripting.

Legal Theories (Pattern Evidence).

- Criminal Conspiracy (18 Pa.C.S. § 903 / 18 U.S.C. § 371). Historic agreement and overt acts.
- Attempted Assassination / Murder (state statutes; 18 U.S.C. §§ 351, 1114). Completed or attempted killings of federal officials and symbolic targets.
- Corrupt Organizations (RICO) (18 Pa.C.S. § 911 / 18 U.S.C. § 1962). Proof of long-running enterprise, with predicate acts spanning decades.

Conclusion.

These four historic defendants are not incidental footnotes. They are foundational proof of an enterprise that scripts shallow alibis, exploits cultural and political symbols, and encodes violence into the national stage. Their acts connect Manson's Helter Skelter to Roske, Butler, and Mangione — the same AutoKnife Conspiracy, running without interruption, rooted in Pennsylvania.

Charlie Kirk's murder was not random. At the very moment when America needed voices of truth, Charlie was **Crucified for the Crime of being Christian.** He lived as a man unafraid to show where his true strength came from, and that faith protected him and the principles he lived and died for. He declared, "I don't have thick skin. It's the full armor of Jesus Christ." For that unflinching witness he was targeted — not because he was expendable, but because he was Irreplaceable: a model Christian whose testimony will endure.

"There is an invisible spiritual war underway." — Charlie Kirk
On September 10, 2025, during a campus event at Utah Valley University, Charlie was fatally shot. His warning proved tragically true: evil revealed itself and struck him down. Yet evil did not prevail—his words endure as testimony that the battle is real, and the cause he defended remains.

Turning Point USA embodied that ethos: this was never merely an academic or policy project. As Kirk himself and many accounts repeatedly framed the organization, "TPUSA is not a think tank. It's a battle tank." His words — rhetorical artillery — armed a generation to confront opponents unflinchingly; that rhetorical framing made Kirk both an inspiration and a target.

Recent public records and reporting confirm how this environment intersected with federal activity and investigations. Documents and oversight disclosures about the post-2020 inquiry known in some reports as "Arctic Frost" show federal scrutiny that touched groups associated with campus politics, including TPUSA. That operation, and the subpoenas and questions it produced, are now part of the public record and help explain how both federal attention and political narrative became entangled with the climate that allowed the AutoKnife pattern to emerge.

The University of Pennsylvania, home of the Biden Center and a locus of institutional influence, illustrates the other side of the coin: institutions that cultivate symbolic figures and cultural flashpoints can — intentionally or not — distract from deeper financial and political compromises. Figures elevated by these institutions are catalogued in KD as **Witnesses** (e.g., Lea Thomas) to show how institutional theater can obscure networks that enable criminal conduct. Use of these witnesses is not a claim of criminality against them; it is evidentiary: they explain the cover, not (at this time) the crime.

These filings — the Butler Brief and the Kohberger Dossier — are not merely chronicles. They are instruments designed to pierce the Culture of Assassination. If prosecuted faithfully, they can expose the architects of this campaign of violence, hold them to account, and restore the notion that no one, however well-connected, is above the law. The ritual of murder must stop; these documents are a step toward that justice.

This work is dedicated to Charlie Kirk: a man of faith, family, and country who gave his voice in defense of Christian roots and paid the ultimate price. May his sacrifice awaken justice, inspire courage, and remind the nation that truth endures even when its messengers are silenced.

Only by exposing the AutoKnife can it be disabled. Only by bringing its operators into the light can America end this war on Womanhood, Christianity and restore the sanctity of life.
