# **Bryan Kohberger** — **Jurisdiction & Venue**

### Monroe County Anchor

Bryan Kohberger's Pennsylvania base in **Albrightsville, Monroe County** provides a clear venue hook. The Poconos themselves carry the infiltration code ("Poke-a-Nose"), while Camelback Mountain stands at the county's center — the "camel's nose under the tent" metaphor for deep-state penetration. Kohberger's presence in this county is not incidental; it situates him within the symbolic geography that defines enterprise continuity. His KA-BAR knife procurement, anchored in Monroe, provides an overt act under 18 Pa.C.S. § 903 sufficient to ground venue.

#### Scranton / Moscow Mirrors

The same enterprise that seeded the "Trump—Moscow" smear through the Russia Collusion Hoax leveraged the Moscow-to-Moscow geographic continuity to stage blood where ink had already been spilled. Venue attaches in Pennsylvania by reason of this deliberate geographic scripting, tethering the Idaho crime scene to Luzerne/Lackawanna County.

## Butler County and the Bullseye

The July 13, 2024 attempted assassination in Butler County, Pennsylvania, further cements venue. Butler is not only a crime scene itself but the **bullseye** of the entire enterprise. - **18 Pa.C.S. § 911 (RICO)** Pennsylvania's RICO statute applies where continuity of enterprise runs through Pennsylvania counties.
- 25 P.S. § 3527 Election interference within Pennsylvania's electorate grounds venue for prosecutorial review.

#### Conclusion

Venue in Pennsylvania is properly laid in:

- Monroe County, by reason of Kohberger's domicile and KA-BAR procurement.
- Luzerne/Lackawanna County, by reason of Scranton/Moscow continuity and symbolic staging.
- Butler County, as the enterprise's bullseye and overt act against Donald J. Trump.

Each county sits within the **Rosemont Seneca Corridor** that underpins the enterprise. Idaho may hold the homicides, and New York may hold the Midtown strike, but **Pennsylvania holds the conspiracy**.
