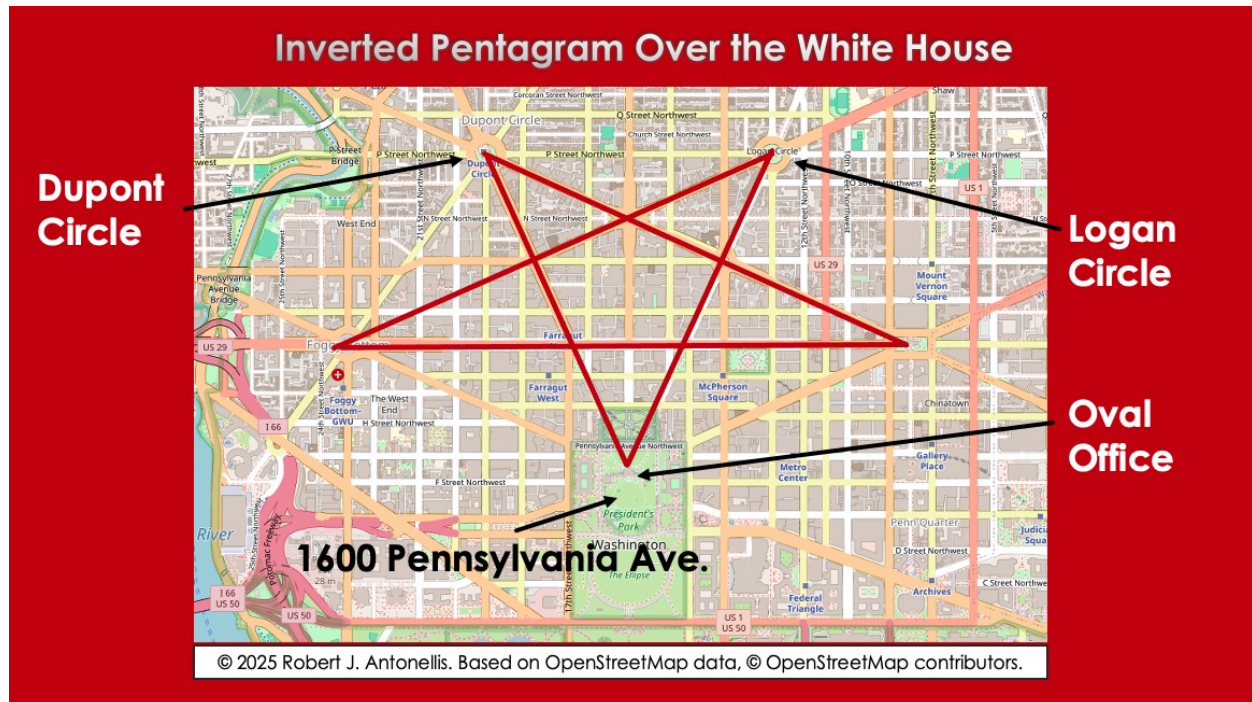

- **Interstate & International Scope** – The network’s operations extend across Pennsylvania, Delaware, D.C., Ukraine, and China, justifying prosecution beyond a single state crime.
- **Connection to the Butler Assassination Attempt** – Evidence suggests that Biden, RSP-LLC, and its associates did more than engage in financial crimes—they facilitated an environment where political violence was not just possible, but inevitable.

- **RICO prosecution expands the case beyond Butler**, granting subpoena power for financial records, forensic audits, and exposure of all co-conspirators, including those who provided financial, logistical, or operational support beyond the gunman.
- **RICO enables civil forfeiture**, allowing the DA’s office to seize assets linked to the Rosemont Network’s financial crimes. Any property, accounts, or business interests used to fund criminal activity or political violence could be confiscated.

- Biden's **June 2024 debate performance** was universally recognized as a **catastrophic failure**.

Kimberly Cheatle's Leadership Failures

 - **Radio Frequency Issues:** There were communication failures due to radio frequency issues, further hindering the response time during the Butler shooting and preventing a coordinated defense.
4. **Rosemont Network and Biden's Political Alignment:**

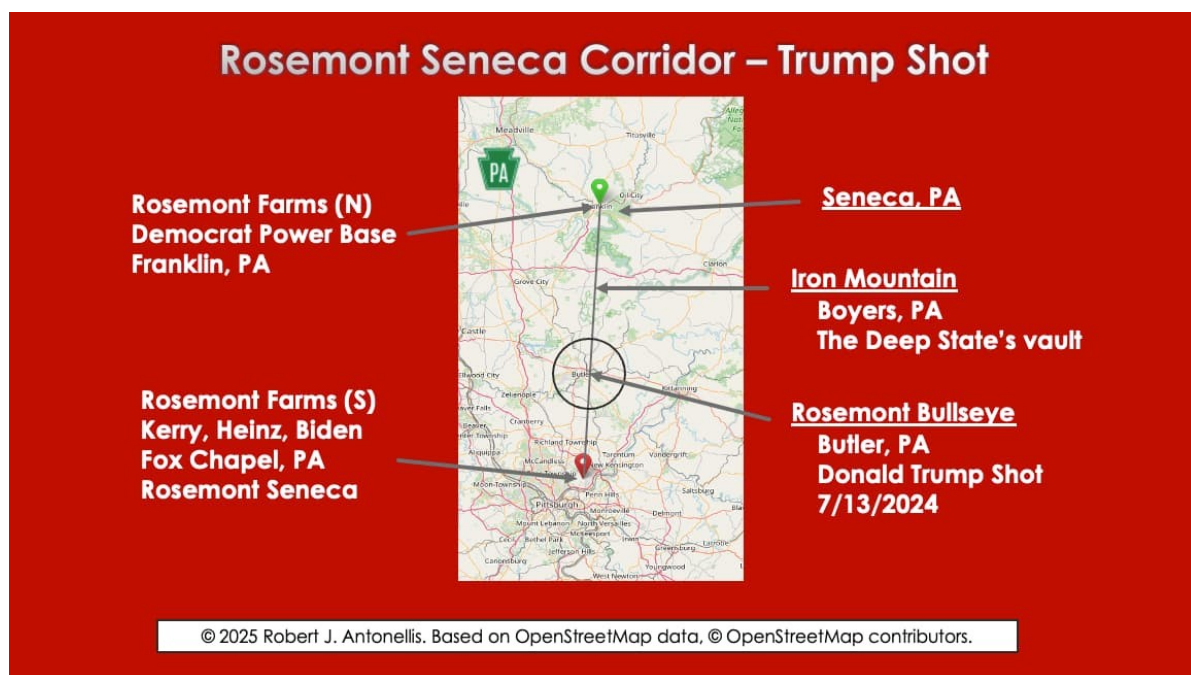
The Rosemont Seneca Corridor: A Loaded Gun Waiting to Fire

- This was not just about Clinton—it was about Bush 41 and 43 setting up the ultimate power transfer.
- George H.W. Bush long anticipated the 9/11/2001 attacks, perhaps from his Skull & Bones days at Yale, ensuring his son, Bush 43, would be positioned as the "GOAT" (Greatest of All Time) president—a leader forged in crisis.
- Hillary Clinton, as part of the deal, agreed NOT to run for president until after Bush 43's second term, which she did. She later complained that “they” would not let her run —“they” being Bush 41, Bush 43, and Bill Clinton, the architects of this political power-sharing arrangement.

The Aftermath: A Political & Financial Realignment

- The immediate removal of a powerful Republican senator cleared the way for a shift in Pennsylvania's political dominance from Republican to Democrat.
- Harris Wofford (D), Pennsylvania Secretary of Labor and Industry, was appointed by Governor Robert P. Casey (D) to fill the U.S. Senate seat following Senator John Heinz's death in 1991.
- John F. Kerry, who would later marry Heinz's widow, Teresa Heinz, gained access to the Heinz family fortune and became a major national political figure.
- Kerry's rise ultimately led to his 2004 presidential candidacy, his connection to Rosemont Seneca Partners, LLC (RSP-LLC) in 2009, and his later role as Secretary of State from 2013 to 2017.
- Bill Clinton's 1992 election victory was made possible, in part, by the weakening of Pennsylvania's GOP stronghold following Heinz's death.
- **Heinz was a distant relative of Donald Trump, sharing ancestry through their roots in Kallstadt, Germany.** This means Trump lost a family member under suspicious circumstances—raising deeper questions about the motivations behind the crash and the political forces at play.

The Rosemont College Connection – Just 4.3 Miles Away

- Heinz's plane crashed just 4.3 miles from Rosemont College, a location with historic ties to political influence in Pennsylvania.
- Patricia Kennedy Lawford—sister of John F. Kennedy—was an alumna of Rosemont College, reinforcing its connections to the Kennedy dynasty and broader elite networks.
- In 1974, then-U.S. Senator from Delaware Joseph R. Biden, Jr. delivered the commencement address at Rosemont College—his only known commencement speech in Pennsylvania or Delaware.
- This appearance connected Biden to the Rosemont name 35 years before the founding of Rosemont Seneca Partners, LLC (RSP-LLC) in 2009, raising questions about how deep his ties to the Rosemont Network truly run.
- Rosemont College's location and the re-emergence of the Rosemont name in high-level financial dealings further cement its importance in Pennsylvania's political and financial landscape.

The Rosemont Estate & Biden's 2009 Recognition

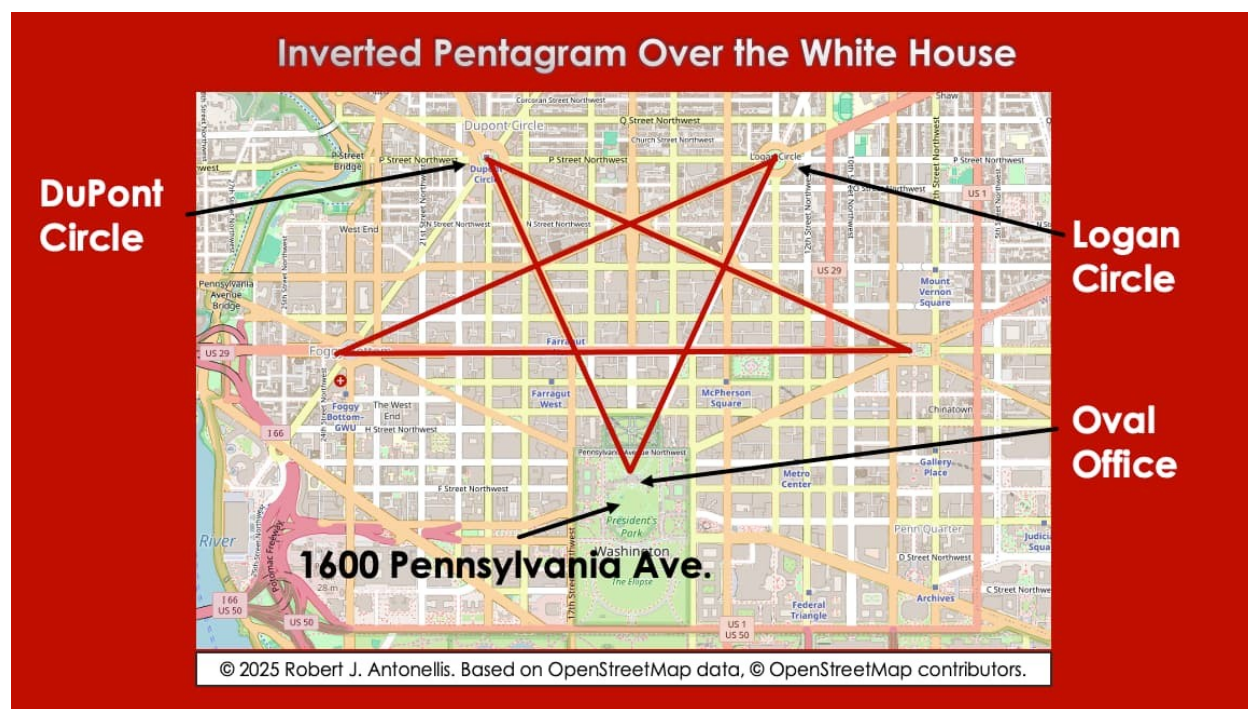

This structure, known internally as **The Axis of Evil**, is centered on a **triangular formation**:

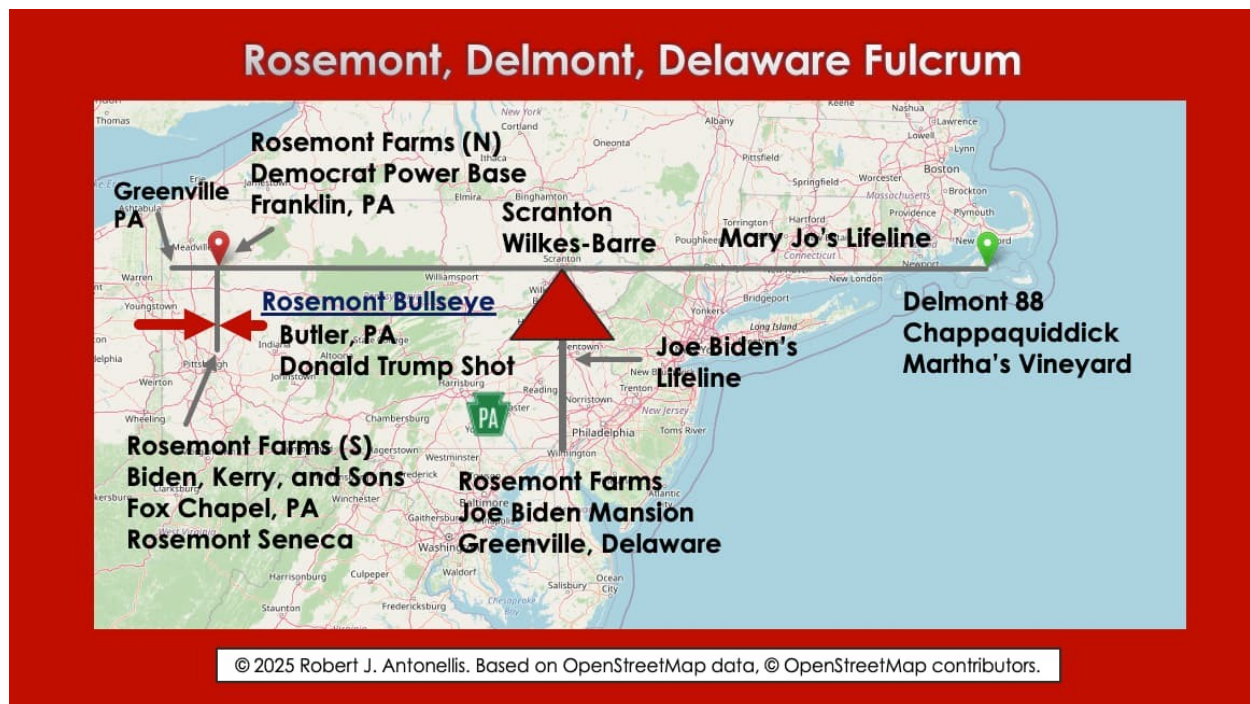
- **Chappaquiddick, MA** (site of MJK's 1969 sacrifice)

My research into the **Scranton-Wilkes-Barre** region led me to a crucial missing piece—the key that made everything **fall into place.** A **14-year-old girl**, Joan Marie Dymond (**JMD**), was kidnapped from **Wilkes-Barre** on **June 25, 1969** after leaving for an after-dinner walk. That was the last time her parents saw her alive.

Her remains were found **decades later**, with DNA confirming her identity. The **Pennsylvania State Police (Troop P)** continue to investigate her **kidnapping and murder**, an **active and open case** in which I have submitted **critical evidence**.

Both were young, white, Catholic women from Wilkes-Barre, Pennsylvania.

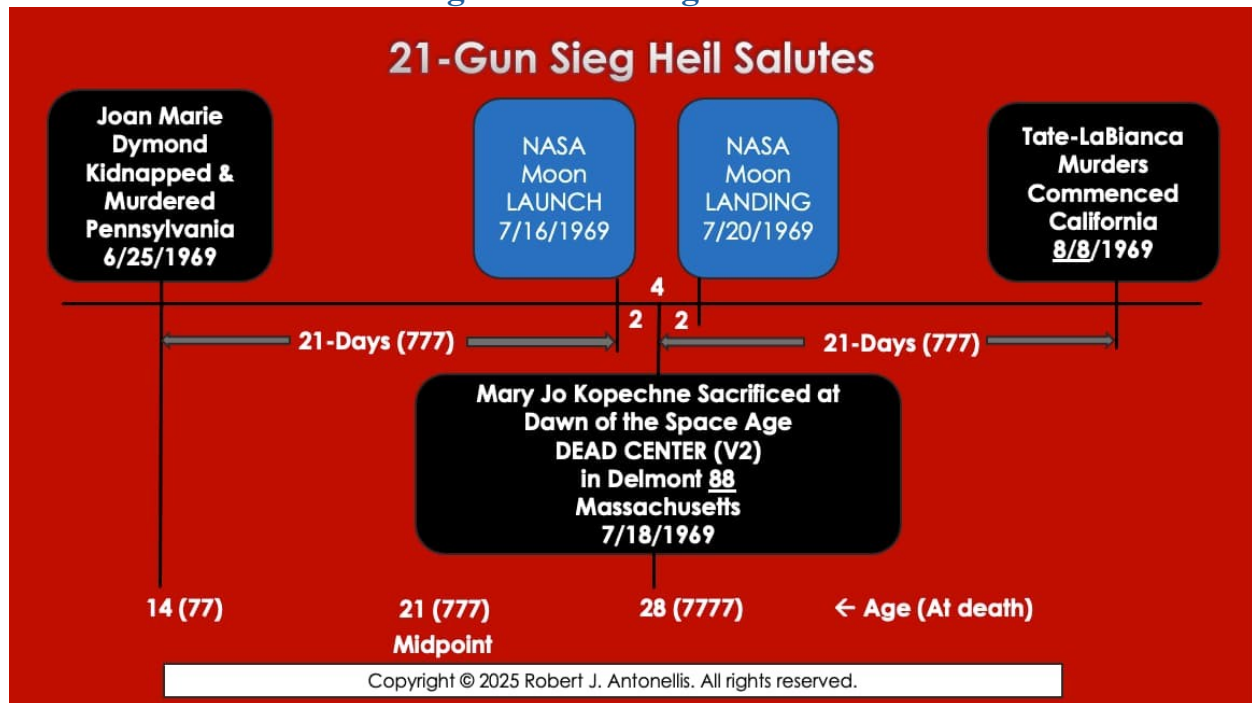
Their ages—14 (77) and 28 (7777)—fit a known numerical pattern, reinforcing that their murders were scripted long beforehand.

Biden's Ties to the Old Democratic South

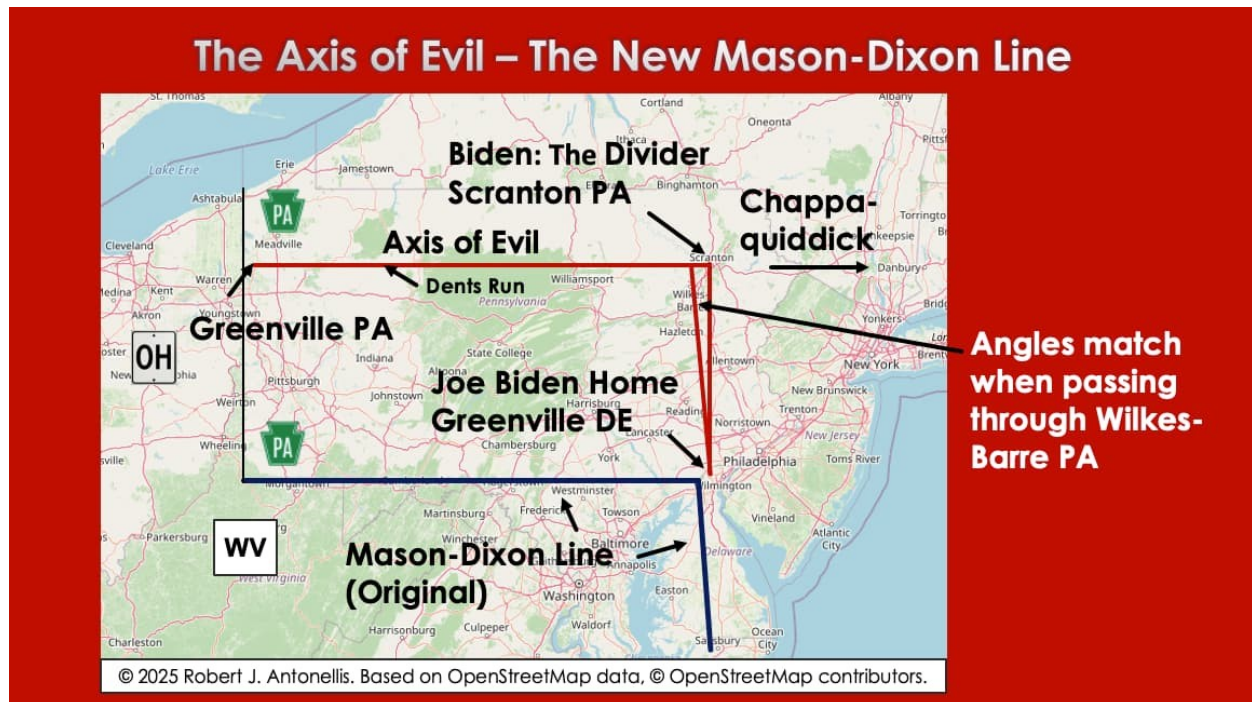

Donald Rumsfeld, who served as Secretary of Defense under Bush, had his own connection to the HIV scandal, holding a personal interest in the first pharmaceutical company to treat AIDS—Burroughs Wellcome, the manufacturer of the highly profitable AZT.

This “Plandemic” narrative raises serious questions about the true motives behind the AIDS epidemic: Was it simply a natural outbreak of disease, or was it part of a larger engineered effort to shift societal norms while growing an industry at the cost of public health? Anthony Fauci: HIV/AIDS as a Proof of Concept for COVID-19

The Fraud of AZT: Fauci’s Hand in the Deception

In the mid-1980s, **Zidovudine (AZT)** was approved as the first drug for treating **HIV/AIDS**. However, AZT was heavily criticized for its **toxic side effects** and **questionable efficacy**. Early **clinical trials** indicated that AZT could cause severe damage to the **bone marrow** and **liver** and **wasn’t effective** at preventing AIDS progression. Yet, the drug was pushed onto the market with **great urgency**, creating a **multi-billion-dollar industry**.

Dr. **Anthony Fauci’s role** in promoting AZT has been controversial. force behind its **mass deployment**, especially considering that more **effective** and **safer** treatments were available, but were intentionally **excluded** from mainstream treatment regimens.

The mRNA “Vaccine” Rush: A Parallel to AZT

Much like **AZT**, the **mRNA vaccines** for **COVID-19** were rushed to market with limited **long-term testing**. The development and distribution of the mRNA vaccines saw **unprecedented speed**, bypassing typical vaccine development timelines. **Fauci’s** leadership in **public health** once again came into focus, as he played a key role in the **fast-tracking** of the mRNA vaccines.

The **AZT scandal** served as a **POC (Proof of Concept)** for the **pharmaceutical model** that would later be applied to the development of **COVID-19 vaccines**. The **lab leak hypothesis**, which suggests that **COVID-19** may have originated from a laboratory accident, remains **unproven**, but it is undeniable that **Fauci's funding** for **gain-of-function research** at **Wuhan Labs** raises significant ethical concerns. The HIV and COVID-19 Parallels: A Pattern of Deception

2. Hydroxychloroquine:

As with ivermectin, patients who may have benefited from **hydroxychloroquine** were left without access to an affordable, **established treatment** option, despite **calls from doctors** and **public figures** to include it in **early treatment protocols**.

3. Vitamin C and Zinc:

- **Vitamin C** and **zinc** have been shown in several studies to play important roles in **immune function**, and both have been suggested as **supplements** to help combat **viral infections**, including **COVID-19**. **High-dose vitamin C**, in particular, has been used successfully in treating **severe respiratory infections** in other contexts, yet these treatments were not promoted as part of the **mainstream** response, which instead focused on **vaccination** and **pharmaceutical drugs** like **mRNA vaccines**.

This deadly combination of **stay-at-home isolation**, a **sedentary lifestyle**, and **misguided ventilator use** mirrors the **early mistakes** made during the **HIV/AIDS** crisis when **AZT** was pushed as the **first-line treatment**, despite its **toxic effects** and **lack of effectiveness**.

The **COVID-19 pandemic**—like **HIV/AIDS**—was exploited for **financial gain**, with **pharmaceutical companies** and **public health officials** profiting from treatments that were not necessarily in the **best interest of patients**. The **mRNA vaccines**, similar to **AZT**, were rushed to market while **safer alternatives** were ignored or actively suppressed.

Just as **AZT** was marketed as the **only solution** to the **HIV crisis**, **mRNA vaccines** were presented as the **only hope** for combating **COVID-19**, despite growing concerns about **safety** and **long-term effects**. Both cases demonstrate a disturbing pattern where **public health responses** were shaped more by **profit motives** than by genuine concern for **patient well-being**.

Biden’s 9/11 Attack on Israel – Placing the Jewish State “in the Bullseye”

The timing of this breach was not random. Then, just one day later, **on October 7, 2023**, Hamas launched its premeditated massacre across Israeli territory, killing over 1,200 civilians in the deadliest anti-Jewish attack since World War II—and taking hundreds of hostages.

Two attacks. Two days. One target: the Jewish people.

The **23andMe breach**, timed to a historical memory of Jewish vulnerability, may have served both as a psychological signal and a tactical tool. Whether the stolen data was used to guide real-world targeting or to intimidate a specific demographic, the result was the same: Ashkenazi Jews were once again put in the crosshairs.

To make matters worse, the breach was not an isolated failure. It reflected a larger vulnerability: the genetic profiling of entire populations, stored by private companies with minimal safeguards. In **March 2025**, 23andMe quietly filed for bankruptcy. The valuation? Just **\$48 million**.

That's **\$48 per victim**.

More than one million lives reduced to a data dump—and a liquidation.

This wasn't just a data breach. It was a **coordinated act of anti-Semitic aggression**, timed for maximum psychological and geopolitical effect. When coupled with the Hamas attack and the symbolic weight of October 6th, it becomes clear: this was not an accident of timing. It was a signal, a coordinated strike, and a violation of every standard of decency.

This Exhibit forms a bridge between the financial assault described in CE18 and the physical-terrain-based alignment detailed in CE19. It reveals that the war against Israel and the Jewish people was fought not only with missiles and dollars, but with **data, timing, and terror**—and that Joseph R. Biden Jr.'s administration, through willful negligence or covert participation, stood by as the countdown unfolded.

It was a calculated blow—aimed not just at lives, but at the very essence of Jewish identity.
