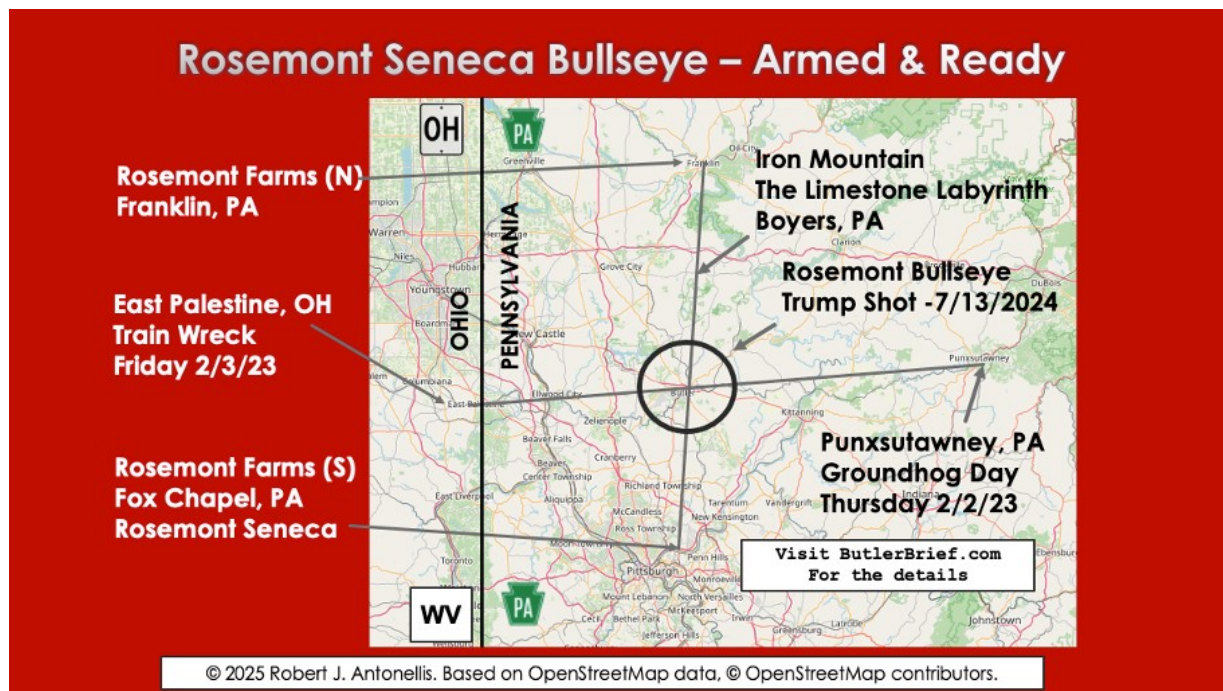

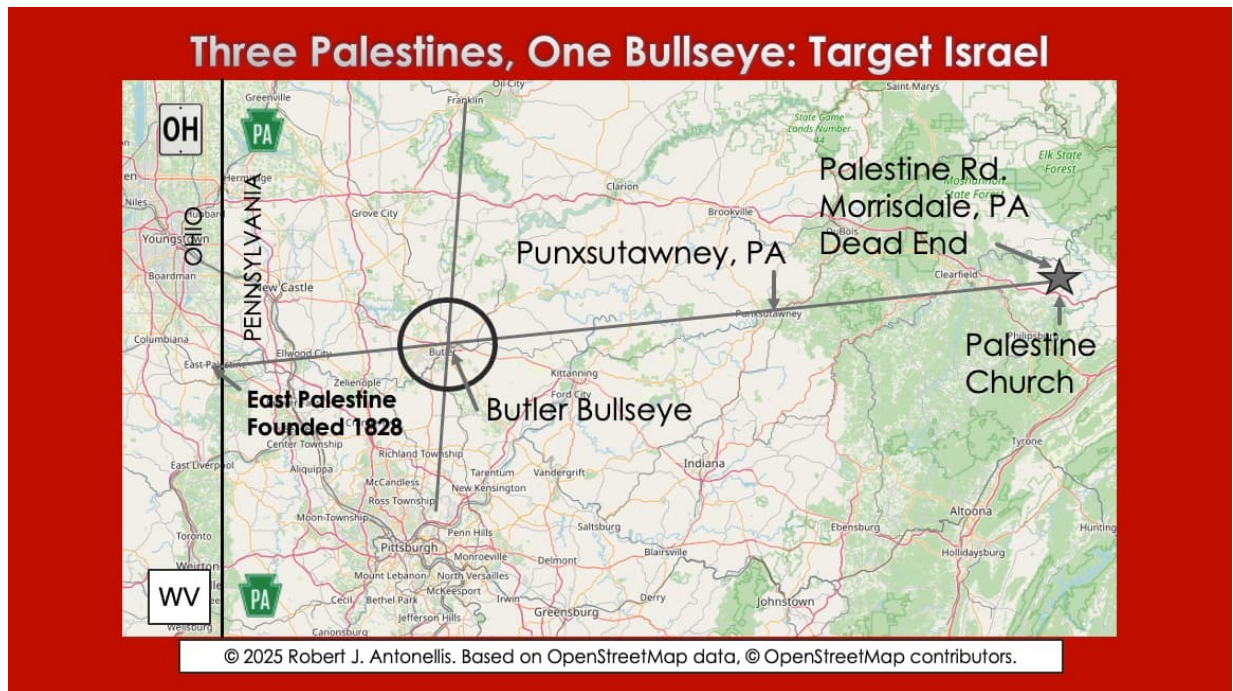

## Violations – Federal Statutes (U.S.C.):

1. **Obstruction of Justice** (18 U.S.C. § 1512)

His work has been incorporated into **FBI training**, helping agents identify **cult victims** based on emotional, behavioral, and cognitive manipulation.

The shooter's behavior and mindset on the day of the attack may be seen as a manifestation of the very tactics Hassan describes in his **BITE model**. Given Hassan's influence on **narrative control**, particularly in the context of **political movements**, it's crucial to consider whether his ideological views on **Trump** and **his supporters** may have been used to **brainwash** the individual who attempted the assassination. The **FBI** and other agencies may need to investigate whether Hassan's model, or similar **mind control** tactics, played a role in radicalizing individuals within the broader **anti-Trump** movement.

## Post-Accident Responses

4. **"Did you know that Teresa Heinz Kerry's inheritance of Rosemont Farms coincided with a significant political shift in Pennsylvania, with the state moving leftward in its political alignment?"**

*Why it's effective:* This question aims to explore potential correlations between personal inheritances and broader political trends, prompting the witness to consider any connections.

5. **"Did you know that after the tragic death of Senator John Heinz in 1991, Harris Wofford, a Democrat, won the special election, marking the first time a Democrat held this seat since 1940? Did you also know that the seat remained in Democratic control until Republican Dave McCormick won the seat in 2024?"**

*Why it's effective:* Introducing this recent political change may encourage the witness to reflect on the factors contributing to the shift, including any influence from influential families or properties like Rosemont Farms.

1. **"Did you participate in any efforts to manipulate or suppress information related to the 2020 election, including the Hunter Biden laptop, and if so, what was your role?"**
