3. The Benghazi Clinton Blood Scandal (CBS #2)

CBS #2, the **Clinton Blood Scandal**, was aimed at **normalizing homosexuality**, **intravenous drug use**, and **pedophilia** as a society's instinctive response to the widespread deaths from **AIDS**, particularly in **Libya**. The attack on the **U.S. Consulate in Benghazi** was part of a broader geopolitical operation orchestrated by groups connected to the **Obama/Biden Administration**, the **CIA**, and the **Rosemont Network**, seeking to facilitate **social change** in North Africa. Investigators should follow the **blood scandal's connections** to the **Clinton family**, as **Bill** and **Hillary Clinton** are deeply involved in this wider **AIDS-era conspiracy**, which includes knowledge of the **9/11**

Blood Chain. The **El-Fateh Children's Hospital**, where **396 children** were intentionally infected with HIV, is located just **a mile** from the former **U.S. Consulate in Benghazi**. This hospital holds critical evidence that can lead investigators to uncover further connections to both **Clinton Blood Scandals**, particularly **CBS #2**, and the **9/11 Blood Chain scandal**.

4. **Collusion with the Enemy to Create Astro-Turf Crowds**

Groups including the **Obama/Biden Administration**, **CIA**, and possibly **Rosemont Network interests** colluded with hostile forces to fabricate **astro-turf crowds** in response to the **Made in America video**. While **Benghazi, Libya** was the only location where this orchestrated effort led to a **military-style attack**, the protests in **Tripoli** and across the **Middle East** were designed to **validate the video** as a **destabilizing force**. These "**spontaneous protests**" were not organic uprisings but carefully orchestrated events, strategically staged to serve the narrative that the video incited violence, providing the **Obama/Biden Administration** with a pretext for the attacks.

Despite these staged efforts, **Benghazi** was the true **target**. The **Benghazi Consulate** had been repeatedly **denied security**—Hillary Clinton rejected **650 security requests** made by **Ambassador Stevens**, leaving the consulate vulnerable. The **attack on Benghazi** was the culmination of this intentional neglect, facilitated by the rejection of security, and later covered up through a **false narrative** about the video.

Investigators should create a **master interrogation list** of individuals involved in the rioting on **9/11/2012** across **Libya** and other countries. Identifying the organizations on-site during the attack and questioning those involved about **who paid for the riots** and **how much they were paid** will uncover the true masterminds of the attack and their financial backers. Additionally, key figures responsible for the **lack of security** at the **Benghazi Consulate**, such as **Hillary Clinton**, should be thoroughly questioned about their role in **rejecting security measures** and whether their actions were part of a deliberate strategy to allow the attack to unfold.

Incorporating Hillary Clinton's Role:

Hillary Clinton's **rejection of 650 security requests** made by **Ambassador Stevens** is a critical part of the **pre-meditation** surrounding the **Benghazi attack**. This decision left the **Benghazi Consulate** exposed, making it an **easy target** for the orchestrated attack. Additionally, Clinton's **destruction of Blackberry devices**, the deletion of **33,000 emails**, and her use of **BleachBit** to scrub data clean are further examples of her role in **covering up the truth** and obstructing justice. Primary Individuals of Interest (Possible Defendants and Co-Conspirators):

1. **George W. Bush (GWB)**
 - Former U.S. President, potentially involved through his broader geopolitical influence and connections to his family's cooperation in the creation of the sequence of four 9/11 events called the 9/11 Blood Chain.
2. **Barak Hussein Obama, Jr.**
 - Former U.S. President, ultimately responsible for decisions made during the Benghazi attack on 9/11/2012. Evidence suggests his administration may have **coordinated, approved, or helped fabricate** the *Innocence of Muslims* video as a **pretext for deflecting blame** and managing fallout from the premeditated attack. He is also implicated in the broader **9/11 Blood Chain** through

coordination with Hillary Clinton, CIA leadership, and foreign policy operatives linked to the cover-up, narrative management, and classified arms transfers in the region.

3. **Bill Clinton**

- In May 2025, a Senate Homeland Security report confirmed that the Biden administration, under Fauci's guidance, **knowingly pushed dangerous mRNA injections while suppressing evidence of myocarditis, blood clots, and other fatal outcomes**. This was not medical oversight—it was a **coordinated act of mass deception**.
- Fauci's orchestration of the mRNA campaign forced doctors, pilots, military personnel, air traffic controllers, and law enforcement into early retirement or resignation. This manufactured instability helped the Rosemont Network tighten its grip on infrastructure, media, and emergency powers during the crisis.
- His dual legacy—first in AZT, then in mRNA—reveals a **pattern of pharmaceutical fraud and biopolitical control**, executed in tandem with Biden's White House and globalist allies. He remains one of the most dangerous enablers of Rosemont's long-range agenda to collapse and control the American Republic.

6. **Al Gore**

- Former U.S. Vice President, potentially involved in the **political maneuvers** tied the Benghazi Blood Scandal (CBS #2) in 1998, and therefore to the **Benghazi attack** of 9/11/2012, and broader **global operations in contrast to American interests**.

7. **Huma Abedin**

- Close associate of Hillary Clinton and a central figure in the private email server scandal. Her silence helped suppress the full truth of **who planned, supported, and benefited** from the 9/11 attacks.

14. Robert Mueller
